## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [\*\*temporary agents\*\*](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [\*\*contract agents\*\*](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe.

Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Unit ESTAT.G.5 is responsible for providing high quality statistical information on Europe's international trade in goods (ITGS). The statistical data on intra-EU and extra-EU trade in goods is used by a wide range of Commission services to develop, implement and evaluate EU policies closely related with potential economic growth and employment creation. The European Central Bank uses the statistical data (in particular euro area data) produced by Unit G5 for the conduct of their monetary policy.

Unit G5 is organised in four teams, respectively in charge of:

- Data production, COMEXT and international cooperation,
- Aggregated data, dissemination and quality monitoring,
- Methodology, legislation and international cooperation,
- Micro-data exchanges.

The project involves the (co-)administration of COMEXT, the unit's production and dissemination database(s), tools and environments, including user rights management. It also involves the specification of the business requirements for the continued development of the components of the COMEXT system, the management of the definitions of datasets and nomenclatures, and the supervision of the data loading activities. In addition, the project involves the participation, as back-up, in the monthly COMEXT data production and dissemination (including dissemination via Eurostat's Data Browser), the provision of secondary level support and training to users, and acting as main contact point for Comext users and the Commission's Directorate-General for Digital Services (DIGIT).



## **WE PROPOSE**

---

Unit ESTAT.G.5 is seeking to hire one IT assistant or statistician or economist.

The position will consist of supporting mainly the unit's team in charge of COMEXT, the unit's production and dissemination database(s).

In addition, depending on her/his knowledge and skills, the successful candidate may contribute to other tasks under the responsibility of Unit G.5.

## **WE LOOK FOR**

---

We are looking for an IT assistant or statistician or economist, preferably with at least two years of relevant professional experience.

Previous experience in database administration would be an asset for this position.

We are looking for a highly motivated colleague with a positive attitude and a strong sense of responsibility and initiative.

The successful candidate should have the following competences and skills:

- sound knowledge and working experience with Oracle, PL/SQL, Linux,
- sound knowledge in business requirements drafting,
- basic knowledge of Angular and WebLogic,
- service-mindedness, commitment, flexibility, availability (at the time of the monthly production) and a strong sense of responsibility,
- good analytical capabilities,
- excellent team spirit.

In addition, the successful candidate should have working knowledge of English.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, or a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new competition published or already planned in the field. If there is none, recruitment will be at the level of AST1, AST2 or AST3. The maximum recruitment grade is AST4, which may be granted under very exceptional circumstances, based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1<sup>st</sup> contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
