In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Eurostat's Unit B3 is in charge of statistical cooperation with Enlargement countries, countries covered by European Neighbourhood Policy (ENP-East and ENP-South) as well as development cooperation with the African continent.

The main tasks of the unit are:

- to support the enlargement countries (candidate countries and potential candidates) in their efforts to align their statistical production with European standards so as to produce comparable and good quality data for national and European policy purposes;
- to support enlargement countries in area of statistics in the accession process;
- to support the countries covered by the European Neighbourhood Policy in their efforts to apply European standards for the production of statistical data that will serve those policies the EU and these countries pursue in common;
- to provide an advisory service to external relation services (EEAS, DG ENEST, DG MENA, DG INTPA, EU Delegations), national statistical authorities and Eurostat units to aid them with respect to development policies and in matters of common interest with non-European regions;
- to develop and maintain tools for specific statistical domains.

Unit B3 consists of three teams (enlargement, European neighbourhood, development) and is a dynamic and friendly unit that offers challenging and interesting work, a good team spirit and a diversity of tasks that stimulate learning and development of colleagues.



The colleague selected via this procedure will support work in the European Neighbourhood team.

## **WE PROPOSE**

---

Eurostat's Unit B3 is seeking to hire one contractual agent to lead the work with a number of European Neighbourhood countries in the East, in particular those with an EU accession perspective and support work related to the implementation and management of large statistical cooperation programmes and projects in these countries. This work includes:

- Acting as the country officer for 2 to 3 countries, including maintaining continuous contact with the statistical offices of these countries, supporting them to design cooperation projects, assessing progress in the development;
- Assessing the compliance of the statistics produced by the countries with European standards;
- Managing contracts, including the review of Terms of Reference for activities, reading reports, following up on deliverables to be provided by the contractor;
- Organising meetings with the beneficiary countries to discuss progress;
- Organising and managing meetings with the partner countries.

We are looking for a candidate with

- A vivid interest in statistical cooperation and working with countries in the European Neighbourhood;
- Knowledge about statistics and experience of working in a statistical domain;
- Willingness to think and reflect on cooperation in the given political context;
- Experience in working with beneficiary countries in any regions of the world;
- A flexible and open mind to adjust to changing circumstances;
- A willingness to learn;
- Good oral and written communication in English.
- Good team working skills.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in a single pdf in the following order:
  1. your CV
  2. completed application form.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
