## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The mission of the PMO (Paymaster Office or Office for the administration and payment of individual entitlements) is to provide a high-quality and user-friendly service to beneficiaries by promptly and accurately managing, determining and paying individual rights and expenses (e.g., salaries, pensions, sickness insurance reimbursements and mission expenses).

PMO.4 Unit in Ispra (Italy) manages the Joint Sickness Insurance Scheme (JSIS) for the staff of the EU institutions, agencies and bodies dependent on the Ispra Sickness Insurance II office and is composed of about 60 persons. It also determines the JSIS membership rights for all active and retired staff of the EU institutions, agencies and bodies.

### WE PROPOSE

---

Unit of PMO 4 is seeking to hire an administrative support agent – a tariffication agent.

Under the supervision of an official or temporary agent, the Administrative Agent will carry out the analysis and calculation of the reimbursable part of claims in accordance with the provisions of the JSIS regulatory framework. (S)He will assist the Team Leader in the handling of the JSIS files in liaison with other teams, sectors and units.

The selected colleague might also be requested to work in another team depending on the needs of the service. This could in particular involve contributing to the PMO's Front Office efforts, responding to phone calls and written staff questions.



## **WE LOOK FOR**

---

This publication aims to fill one position.

We are looking for an administrative support agent – a tariffication agent.

The ideal candidate should:

- have at least three year's prior experience in the fields of sickness insurance, or human resources, or finance
- have excellent client-oriented service culture
- good computer skills (Word, Excel, PowerPoint, Outlook) and willingness to invest in acquiring sufficient knowledge of the EU administrative rules and procedures
- know the Staff Regulations and the Conditions of Employment of other agents
- knowledge of the Joint Rules of Joint Sickness Insurance Scheme and the General Implementing Provisions for the reimbursement of medical expenses would be an asset.

Additionally, the selected candidate should demonstrate the following personal qualities:

- be discrete and able to work with confidential issues
- analytical and problem-solving skills
- an eye for detail and very good numerical skills
- very good interpersonal skills
- a proven ability to work in team, while handling the assigned tasks autonomously
- very good work organisation and planning skills
- stress resistance and ability to handle significant workloads with tight deadlines
- flexibility and openness to new requirements, procedures, technologies
- initiative and proactivity in proposing pragmatic solutions

The main working languages of the unit are French and English., and the knowledge of other EU languages is beneficial for the service, taking into consideration the population of customers we serve.

Please note that references should be made available upon request.

The selected candidate is expected to be client-oriented and might be required, in the interest of the service, to work directly with customers, for instance, in the JSIS front office team.

PMO is working towards full alignment of the Joint Sickness Insurance Scheme across the 3 JSIS sites (Brussels, Luxembourg and Ispra). Your functions and job content are likely to evolve as a consequence of these endeavours.

The candidates are susceptible when needed by the service to provide support to other teams.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in a single pdf in the following order:
  1. your CV
  2. completed application form.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be in **Ispira**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The first contract will be 1 year. The contract may be renewed in the interest of the service for a fixed period. If a second renewal is in the interest of the service, the contract will be for an indefinite duration.

The duration of the renewal will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

The selected candidate shall serve a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
