STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Office for Infrastructure and Logistics Luxembourg (OIL) is an administrative office with almost 430 staff.

Our main task is to provide all Commission staff in Luxembourg with a suitable working space in terms of comfort and safety and to ensure the establishment of social and logistical infrastructure.

Our services, which are always carried out in accordance with a quality approach, are also delivered to other European Institutions and bodies present on the Luxembourg site.

Unit OIL.02 is composed of approximately 50 people and is divided into 2 sectors. It is responsible for managing the Mail Service, the Office's document management system, conferences facilities, IT, OIL communication measures and implement the health and safety at work policy on the Luxembourg site.

WE PROPOSE

OIL.02 is looking for a highly motivated, dynamic and rigorous colleague to act as the secretary of the Head of Sector for Conferences – Document Management

Among other things, he/she will have to:

- Provide organisational, logistical and administrative support to the Head of Sector, in the day-to-day management of his/her activities, as well as to the Head of Unit and his/her deputy, as required;
- Provide administrative support to teams in the sector;
- Carry out varied and interesting tasks;
- Provide support to the other secretaries of the unit and provide back-up in case of absence;
- Promote efficient and smooth communication, both within the unit and within the Office, and with external stakeholders;

This requires working closely with the Head of the Sector concerned, the assistant to the Head of Unit, the secretary of the Unit and members of the administrative and operational teams in the sector. You will join a motivated and committed team, with a good working atmosphere, and your role will be to facilitate the smooth functioning of the service.

WE LOOK FOR

OIL.02 is looking for a discreet and autonomous secretary with at least five years' experience in the secretarial field, to act as a liaison between the Head of Sector and his/her teams.

The ideal candidate shall have:

- very good ability to organise/manage the agenda of the Head of Sector, as well as that of the Head of Unit and his/her deputy, if necessary;
- a very good sense of initiative;
- the qualities needed to communicate well/work in a team;
- in-depth knowledge and skills in the secretarial field;
- excellent drafting skills especially as regards drafting in a clear and concise manner;
- excellent knowledge of the Commission's standard office tools and software (Outlook, Teams, Word, Excel, Powerpoint, Ares, etc.);
- the necessary skills to establish and maintain very good relations with colleagues and stakeholders and the flexible attitude in order to be at their service and to meet the needs of various units/DGs.

An excellent command of French both orally and in writing is essential and a good knowledge of English is necessary.



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:
 - 1. your CV 2. completed application form.

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Oualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²

• AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in French and possibly in a second official language.



2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG II. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. The contract may be renewed in the interest of the service for a definite duration. If a second renewal of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
