STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Resolution Task Force of DG FISMA is the lead service of the Commission for bank resolution in the context of the Banking Union. The Resolution Task Force is responsible for preparing resolution decisions and for supporting the implementation of the Single Resolution Mechanism.

WE PROPOSE

An interesting and challenging job in the Resolution Task Force, which is responsible for:

• supporting the Commission's representatives at the Executive and Plenary sessions of the Single Resolution Board (SRB):

• following and providing input to the work of the SRB;

• applying, monitoring and defending in court cases the legal framework for the functioning of the SRB and Single Resolution Fund;

• reviewing resolution plans and early intervention measures;

• coordinating with other Commission Services in the context of preparing Commission resolution decisions;

• coordinating with the SRB, the Council, the European Parliament, the European Central Bank (ECB)/Single Supervisory Mechanism (SSM), the European Banking Authority (EBA), the Financial Stability Board (FSB) and third-country authorities on resolution matters;

• analysing EU bank State aid decisions and coordinating FISMA's response.

There may be also occasional missions in order to follow resolution work at international level or hearings in litigation cases at the ECJ.

The Resolution Task Force offers a friendly and stimulating working atmosphere, with a high degree of autonomy and responsibility and aims for an optimal work/life balance.

Discussions and exchange of opinions are encouraged.

WE LOOK FOR

Candidates should be practical and task-oriented, with a sound legal and/or economic background and with very good analytical, drafting and communication skills.



A background in financial analysis as well as a good knowledge of banking law and/or knowledge of State aid legislation and procedures would be clear advantages.

The candidates should be capable of working independently as well as within a team (as we are a small unit, team spirit is essential), as well as possess very good analytical skills with an eye for the detail, the ability to conduct legal/economic analysis and develop sound argumentations, the ability to communicate effectively, and the ability to work under time constraints and pressure.

5 to 10-year work experience, including experience directly related to the management of the Single Resolution Mechanism framework, including its financial arrangements, would be a strong asset.

The main language of the unit is English. Knowledge of other Union languages would be an asset.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- * have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^2}$
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other</u> <u>Servants</u>, in function group AD.

> Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the 1^{st} contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
