STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of OIB is to ensure a functional, safe and comfortable workplace for Commission staff and to provide high quality support services, based on a client-oriented approach in an environmentally friendly and cost-effective way. The OIB.LS department's mission is to provide, both to the institution and its personnel, a wide range of logistic and support services that contribute to the well-being and good functioning of all Commission services.

The department consists of 4 units (3 in Brussels and 1 in Ispra):

- LS.1: Historical Archives, Mail Services, Visual Design and Print
- LS.2: Transport, Mobility and Logistic Services
- LS.3: Social Infrastructure: Ispra
- LS.4: Catering Unit

LS.3 is responsible for managing social infrastructure for Commission staff and their families in Ispra – Varese (I).

These infrastructures managed by the unit include the Catering Services (canteens, cafeteria, banqueting, "Saletta"), Childcare Services (crèche and afterschool facilities), temporary accommodation for new arrivals as well as a Club House. The Club House offers a catering service (restaurant and bar) whose management is the responsibility of the OIB through an external supplier.

WE PROPOSE

LS.3 is seeking to hire one accounting and financial management assistant. The post will consist of ensuring accounting and financial management, carrying out ex ante verification of the legality of financial transactions, regularity, internal procedures, and sound financial management, and contributing to the reporting and control of commitments, expenditures, and recoveries as well as supporting and training relevant staff on financial and accounting matters.

Within unit OIB.LS.3 you will be responsible as a Temporary Agent AST for performing ex-ante verification of the conformity of all type of financial operations with legality, regularity, internal procedures, including sound financial management. Tasks also include producing reports on commitments and expenditures and recoveries as well as supporting and training relevant staff on financial and accounting matters.



Your main tasks will be:

- Applying financial regulations and OIB internal instructions
- Ensuring the monitoring of accounting operations (accounting data quality)
- Supporting budget preparation and monitoring
- Producing and updating budgetary and financial procedures
- Preparing financial documents, statistics and reporting
- Contributing to procurement processes on the financial component

The job also includes some routine tasks related to financial processes and administrative procedures.

WE LOOK FOR

An accounting and financial management assistant to take up the challenges of this position and to pro-actively perform his/her tasks with strong commitment and high professional standards. The ideal profile for the job is:

Required

- A level of higher education in the field of accounting, finance or related field.
- Professional experience of at least 5 years in the field of accounting and financial management.

Desired

- Strong knowledge of financial regulations and budget management, particularly in the context of a public administration and preferably in the European institutions.
- Experience in the management of financial transactions in an SAP environment.
- Advanced computer literacy, notably for setting up, analysing and using databases (Excel, M365 tools, etc.)

- Organisation and planning, respect for deadlines, ability to set priorities
- Analytical thinking

ANNEX

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Oualifications:

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, <u>or</u> a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and in French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

Type of contract and working conditions

The place of employment will be Ispra.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** Conditions of Employment of Other Servants, in function group AST.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new competition published or already planned in the field. If there is none, recruitment will be at the level of AST1, AST2 or AST3. The maximum recruitment grade is AST4, which may be granted under very exceptional circumstances, based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
