#### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

Unit G4's mission is to assist Italy and Malta to manage their cohesion policy programmes effectively and to gain maximum long-term benefit from the funds made available by the European Union. In close partnership with national and regional authorities, the unit monitors and assesses the implementation of programmes and operations and provides advice to stakeholders on relevant policy and implementation issues. The unit consists of 21 members with good gender balance and a variety of background profiles.

#### **WE PROPOSE**

We propose a job as programme manager. The jobholder will work on the implementation of 2021–2027 programmes under the responsibility of the unit. In addition, he/she will be also involved in the finalisation of the 2014–2020 programmes and the preparation of the corresponding closures. The job involves processing annual reports; initiating payments; following up on audit issues that might arise for his/her programmes; attendance at annual performance meetings and monitoring committees; liaising with the national and regional authorities and stakeholders: communicating on topics related to the programmes managed; preparing briefings and presentations or dealing with queries from stakeholders and citizens.

The jobholder will have policy-related horizontal responsibilities and will be expected to act as first point of contact for the unit in these matters and to provide advice and guidance to unit members. These will include, inter alia, providing advice and expertise on some of the current political priorities for the Commission: energy transition and sustainability aspects, including climate aspects; territorial development, in particular urban policy and policies for inner areas; housing, where he/she will be expected to advise and support the unit on the new housing priorities and the practical aspects of cohesion policy support to it.



#### **WE LOOK FOR**

We are looking for an enthusiastic, committed colleague with:

- a strong interest in and good working knowledge of cohesion policy.
- excellent knowledge and practical experience in housing matters; urban issues and territorial development models; and energy and sustainability issues with a particular focus on climate issues and energy transition. Practical experience in these areas and knowledge of practices in other international institutions would be an asset.
- sound knowledge of Commission financial and administrative rules.
- very good organisational skills and ability to prioritise between competing deadlines.
- excellent Italian and English oral and written skills and very good working knowledge of French.

## 1. Selection

# > Am I eligible to apply?

#### You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Oualifications:**

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

## Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $FU^2$
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

# What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

#### 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, in function group AD.

#### Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
