STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate General Customs and Taxation (DG TAXUD) mission is to promote fair and sustainable policies that generate revenue for the EU and its Member States and ensure that EU citizens and businesses benefit from global trade and a safe and secure Single Market protected at its borders.

Within DG TAXUD, Directorate C is developing an overall policy in indirect taxation, including financial sector taxation as well as environmental, transport and energy taxation, VAT, excise duties and tax administration. It is also responsible for developing and implementing the Carbon Border Adjustment Mechanism and tax initiatives included in the European Green Deal. The Directorate includes 88 staff with a good mix of officials, temporary and contract agents and national experts.

Unit C.5 is responsible for providing sound economic analysis to support EU policies in the field of indirect taxation, developing methodologies for the operation of the EU Carbon Border Adjustment Mechanism (CBAM), contributing to EU tax policy development and co-ordination of indirect tax matters in financial sector taxation or other sectors currently exempt from VAT. It works closely with the Principal Adviser to the Director-General, and it is also coordinating the contribution of Directorate C to the European Semester.

The C.5 team is working closely with other units in the directorate and the DG. The unit is relatively recent and fast growing. The team is made up of motivated colleagues with very different backgrounds including in economics, climate & environmental policies, engineering, policies and law.

WE PROPOSE

TAXUD Unit C5 is seeking to recruit an Administrative Agent (Contract Agent Function Group II) as part of a dynamic, motivated and supportive team, to deal with typical secretarial and



administrative support tasks to help the unit deliver on its broader tasks. In particular, the new colleague will support the fast-growing CBAM team in Unit C5, which is developing a ground-breaking climate policy instrument.

The new colleague will perform a varied and interesting range of different activities such as:

- optimising the flow of information within and outside the unit by opening/registering/filtering, routing incoming mail to appropriate colleagues in the unit and registering outgoing email.
- organising meetings with Member States and other stakeholders, including by booking rooms, preparing documentation, providing logistic support before and during the meetings;
- managing work missions of colleagues;

Depending on the background and interests of the new colleague, the successful candidates will also be called to contribute to other activities of the Unit.

WE LOOK FOR

To complement our team, we look for a motivated, open-minded (including an open attitude to learning), dynamic colleague, with a positive attitude, a good sense of humor, and team spirit. The new colleague should have good organisational skills and a good sense for priority setting. They should also have good communication and inter-personal skills.

Familiarity with standard office tools (in particular Word, Outlook, Teams) is important.

A good command of English (written and oral) is essential, any other language, in particular French, would be considered an asset.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 2. You should send your documents in a single pdf in the following order:

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG II.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.
