STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the Directorate-General for Justice and Consumers (DG JUST) is to vindicate and strengthen the rights of people living in the European Union, whether they are acting as citizens, as entrepreneurs, as consumers or as workers, wherever they are in the EU. To do this, we aim to build a European Area of Justice, and to support the development of a dynamic single market for consumers, workers, and business, contributing to growth.

The Directorate-General is structured in 5 Directorates of which Directorate H is DG JUST's knowledge and enabling hub as well as the "Resources Directorate".

Our mission is to "make it happen", by covering all activities ranging from planning, better regulation and enforcement, briefings, inter-institutional relations, communication, as well as budget, programmes and financial management, to IT system development, logistics and document and knowledge management.

The mission of Unit H4 is IT development and maintenance, design and implementation of knowledge and document-management policies, data protection compliance coordination and logistics management, in close collaboration with Commission horizontal services and domain leaders.

WE PROPOSE

Unit H.4 is seeking to hire an **IT Project Assistant** position as part of the team responsible for developing and maintaining a portfolio of IT systems. You will be part of an excellent team of professionals, with flexible working environment. You will plan, monitor, control and report on the state of plan of your projects and in particular:

- Be responsible for one or more IT systems, aiming at an overall result that matches the expectations of all stakeholders.
- Be responsible for a development team;
- Elaborate project strategies and planning, define work plan and deliverables, supervise the project



review and deliverables,

- Organise quality control, identify and analyse (potential) risk and define and implement risk reduction actions, report on project status, organise change control;
- Contribute to corporate governance, security and data protection compliance tasks for the DGs.

WE LOOK FOR

We are looking for a dynamic, enthusiastic and proactive person with a strong sense of service, a very good team spirit, willing to learn and to share experiences with others.
A minimum of 3 years of relevant professional experience is required.

The ideal candidate will be expected to possess:

- Ability motivate a team of IT-related professionals;
- Excellent knowledge of project management standards, methodologies and activities, in particular of planning, requirements engineering, monitoring, controlling, testing and reporting;
- Good knowledge of Agile principles and practices;
- Proficiency with project management and tracking tools (Ms Project Plan, JIRA);
- Good IT technical knowledge, to be able to manage IT projects (Java, HTML5, DRUPAL, Reporting tools);
- Ability to give presentations;
- Ability to participate in multi-lingual meetings, good communication skills;
- Ability to work in an international / multi-cultural environment, experience in working in teams;
- Results oriented mindset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, or a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

Based on the CV and application form submitted, a selection panel will choose a limited number of candidates for interviews. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language (possibly in French).

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new competition published or already planned in the field. If there is none, recruitment will be at the level of AST1, AST2 or AST3. The maximum recruitment grade is AST4, which may be granted under very exceptional circumstances, based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
