STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

DIGIT.C.5 supports the Commission's Digital Workplace (DWP) by delivering IT tools and services to all staff. Key services include:

IT Helpdesk: Serving 35,000 users with ~500,000 annual requests.

Device Logistics: Managing 400,000+ IT assets (laptops, screens, mobiles, etc.).

Staff Onboarding: IT setup for new employees.

Roll-out Support: Assisting with deployment and change management of DWP solutions (developed by DIGIT.C.2).

The unit operates through four sectors:

Front Office: First-level user support, including VVIP assistance. Logistics & Inventory: Full lifecycle management of IT equipment.

Role Purpose: The IT Service Assistant ensures high-quality DWP support through customer account management, stakeholder communication, and coordination of technical/process activities. Responsibilities include problem management, service improvement, quality control, and promoting effective communication and digital tool evolution

A job opening for an Assistant who will work in the **Quality and Processes team**, as a Digital Workplace-Customer Account Manager (CAM), reporting directly to the Head of Sector.

The key role will be to ensure the IT support services administration (implementation, operation, improvement and projects), notably:



- For a dedicated portfolio of Directorates General, be the contact point to these entities for the unit.
- Participate in the organization and running of communication events.
- Participate in Digital Workplace related projects.
- Coordinate technical activities with a mix of process and project work.
- Participate in Digital Workplace activities led by the unit and other entities in DIGIT and the IRM team of the customer DGs.

We are looking for an enthusiastic IT professional with a service-minded attitude, excellent communication skills, and a flexible, dynamic approach to work. The ideal candidate holds a bachelor's degree of at least three years in a field relevant to the job requirements and brings a solid foundation in IT service delivery and customer engagement. Key qualifications include:

- Good understanding of IT Service Management;
- Proven experience in large-scale support environments, ideally within the Digital Workplace domain:
- A collaborative mindset and the ability to work effectively in a team;
- Background in IT project management, especially in infrastructure-related initiatives;
- Fluency in English, both written and spoken. Knowledge if French is an asset.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> <u>C(2017)6760</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 3 years.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
