### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

The mission of Unit EMPL.G.4 "Financial Implementation and Procurement Centre" is to contribute to the sound and efficient management of the financial resources of DG Employment, Social Affairs and Inclusion in direct, shared and indirect management. The unit is composed of 46 staff members in charge of financial activities, from the approved Financing Decision to the final payment, for both procurement and grants and financial transactions in structural funds management.

The positive and dynamic working relationships both within the unit and between the unit and its customers will contribute to making the job enriching, motivating and with opportunities for further professional development in the Directorate General or further in the Commission.

#### **WE PROPOSE**

Unit EMPl.G4 "Financial Implementation and Procurement Centre" of DG Employment, Social Affairs and Inclusion is seeking to hire one **Finance and Contracts Assistant - Grants and Procurement.** 

The successful candidate will implement various financial transactions in direct and indirect management mode. He/she will have a full overview of the very wide set of procurement contracts implemented by the Directorate General in several EU programmes. He/she will have the task to support and provide advice and service to operational Units with a view to ease operational initiation, verification and authorisation of a wide variety of transactions and preparation of contracts.

This might include helping the operation units in the preparation of procurement contracts, issuing and managing procurement related documents, budgetary commitments in conformity with the financial regulation and the sound financial management principles. The colleague also will be also

cover the financial verification of invoices submitted by contractors (role of Financial verification agent) and the related the accounting procedures in the Commission.

The colleague will have regular communication with the various operational units of the Directorate General that are using direct and indirect management mode.

#### **WE LOOK FOR**

We are looking for candidates meeting the following requirements:

- knowledge and experience in financial transactions in direct management, and more especially procurement activities as well as the provisions of the Financial Regulation
- experience with accounting and management of IT systems for accounting
- good capacities in:
- i) analysing and solving problems;
- ii) capacity to communicate technical (financial/legal) information;
- iii) experience in using IT tools for contract management would be an advantage.

#### **HOW TO EXPRESS YOUR INTEREST?**

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

## 1. Selection

## Am I eligible to apply?

### You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <a href="EPSO CAST">EPSO CAST</a> data base.

#### **Oualifications:**

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

### What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

### 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with  $\underline{\text{Commission Decision}}$   $\underline{\text{C(2017)6760}}$  laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, Commission Decision C(2017)6760 on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.
