STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Human Resources and Security Directorate General (DG HR) oversees recruitment policy, training and career management, social policies and working conditions for Commission staff. It is also responsible for keeping buildings and employees safe and secure, making sure that work continues during crises and dealing with online security

Unit HR.D.2 "Support Services for Active & Retired Staff" deals with health and Well-being, working conditions, assistance to active and retired staff and comprises approximately 45 staff members.

Our unit comprises the following sectors:

- Welcome and departure desks in Brussels
- The 'Expat' administrative support sector
- Coordination and development of health and social policy
- the Social Service and budget support for staff and their family members with disabilities
- Social support and relations with pensioners.

WE PROPOSE

We recruit an Administrative Assistant to assist the Expat Administrative Support Sector.

The duties cover the administrative management of matters relating to the Protocol on Privileges and Immunities. You will be responsible for managing formalities concerning statutory staff moving from a third country, for the administrative follow-up of VAT-free purchases on entry into service, for registration and for the customs clearance of vehicles.



The work proposed is very diverse and requires good communication and administrative management skills. You will be in contact with staff in an open-space office with guests by appointment.

The sector will provide training.

WE LOOK FOR

Do you like to communicate and are you service-oriented?

Are you willing to thrive in a dynamic team?

We are looking for a colleague with excellent organisational skills, strong attention to detail and accuracy, a proactive attitude and a problem-solving mindset in a fast-paced environment. He/she should be motivated with a strong sense of teamwork.

The jobholder will have to be flexible and adaptable given the diversity of tasks to be performed. He/she must be able to exercise discretion because of the processing of the personal data of officials/other staff. A good command of written French and a good knowledge of English are essential. Knowledge of Dutch is an asset, as duties may involve correspondence with Belgian ministries.

The jobholder must also be able to work under pressure and demonstrate assertiveness and mediation skills.

Previous experience in an administrative or office support role is an asset.

The organisation of work within the unit allows for a good work-life balance.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.



- 2. You should send your documents in a single pdf in the following order:

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in French and English.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on
Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\underline{\text{Commission Decision}}$ $\underline{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.
