STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the PMO (Paymaster Office or Office for the administration and payment of individual entitlements) is to provide a high-quality and user-friendly service to beneficiaries by promptly and accurately managing, determining and paying individual rights and expenses (e.g. salaries, pensions, sickness insurance reimbursements and mission expenses).

PMO.1 "Rights and salaries" is responsible for:

determining and managing the individual financial rights of around 45 000 people when they first start working for an EU institution or body, and whenever a life or other event changes those rights;
calculating and paying salaries and allowances for approximately 50 000 people per month;

• addressing queries and complaints from staff about their salaries and their rights.

The unit works in teams, each of which is responsible for different processes falling under the unit's responsibility (e.g. Payment of Salaries, Establishing Rights on entry into services, Family Allowances, Dependent Child Allowances, Allowances received from other sources, Helpdesk). Each team is led by a Team Leader under the supervision of a Head of Sector.

There are about 110 staff members split across three Sectors. The unit aims to provide high quality and in-time services to staff, the Commission, other Institutions, Agencies and bodies in a transparent and customer oriented way, so that Institutions and their staff can get on with their work.



WE PROPOSE

PMO.1 is seeking to hire 2 Administrative Agents – Salaries and Individual Rights.

An agent's salary includes the basic monthly salary plus allowances to which one is entitled (e.g. expatriation, household, child, education). Deductions are then applied for taxes, pension, unemployment contributions (when relevant), health insurance contributions and allowances received from other sources. In some cases (when relevant), other deductions may also be made directly from salaries (such as for childcare services used).

Depending on the place of employment of the agent, salary may also be subject to adjustments for differences in the cost of living between countries.

In addition salaries may be adapted to reflect increase in salary following a promotion but also changes for cost of living and/or exchange rate changes.

Working under the supervision of an official or a temporary agent, the Administrative Agent will:

• Manage a series of salaries/payslips (around 3 000 files).

• Carry out all necessary activities to ensure that agents are paid correctly and on time.

• Ensure that the relevant procedures are applied correctly (debt letters, pre information letters, transfers based on the article 17 of Annex VII of the Staff Regulations etc.).

• Contribute to maintaining business continuity in case of absences.

• Undertake controls on the payroll system, liaise with colleagues within the PMO, the Human Resources, the other agencies/institutions, and the clients.

The selected colleague might also be requested to work elsewhere in the PMO depending on the needs of the service. This could in particular involve contributing to the PMO's Front Office efforts, responding to phone calls and written staff questions.

WE LOOK FOR

We are looking for two motivated colleagues with good numerical and client service skills, able to maintain confidentiality and respect for the privacy of the clients.

The ideal profile for the job has:

• prior experience (or an educational background) in the field of payroll or business administration, accounting, taxation, management control, audit;

- great attention to detail and good analytical capability;
- excellent organisational skills;

Additionally, the selected candidates should demonstrate the following personal qualities:

• ability to work autonomously and propose pragmatic solutions;



- comfortable with handling tight deadlines as well as a monthly workload peak;
- capacity and willingness to learn; it takes 6-12 months to become fully operational;
- flexibility and openness with regard to new requirements, procedures, technologies.

Please note that the PMO places great importance to customer service. The candidate is expected to be client-oriented and might be required, in the interest of the service, to work directly with clients, for instance in the front office team.

The main working languages are French and English, and the knowledge of other EU languages is beneficial for the service, taking into consideration the population of customers we serve.

The candidates are susceptible when needed by the service to provide support to other Sectors.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^2}$
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG II.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. The contract may be renewed in the interest of the service for a definite duration. If a second renewal of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
