STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG EMPL is the DG within the Commission that develops and carries out the Commission's policies on Employment and Social Affairs and on Training. Examples of the areas in which we are active include support for:

- More and better jobs through the European Employment Strategy (which brings national policies closer in this field) and the <u>European Social Fund</u> (€9 billion per year managed in partnership with the Member States).
- <u>Free movement of workers</u> and <u>coordination of social security schemes</u>, which means that every EU national has the right to work and to live in any EU country and that people who move between countries are not disadvantaged in relation to social security including healthcare.
- <u>Social inclusion</u> by supporting efforts to combat poverty and social exclusion, reform social protection systems, assess new demographic and social developments.

Directorate C works towards promoting social dialogue and improving working conditions through effective labour law and safe and healthy working environments.

More specifically, the mission of Unit EMPL C.1 is to oversee the implementation of EU law on workers' individual rights and on their collective rights to information and consultation in companies.

The successful candidate will be responsible, as part of a secretarial team of three, for assisting and providing administrative support to members of the unit in the implementation of its annual work programme.

Our future colleague will be responsible for ensuring the correct and up-to-date use of relevant Commission procedures and tools. He/she will a.o. be in charge of:

- Manage records, record and handle documents in accordance with the European Commission procedures;
- Provide support to the handling of complaints in the dedicated complaints handling-module;
- Contribute to the organisation of expert group meetings and other meetings/events;
- Request and handle translations;
- Help colleagues with the organisation of their missions;
- Support the unit's work in terms of financial management.

WE LOOK FOR

We are looking for a person with good administrative and secretarial skills. We are looking for someone able to multitask and to adapt to new situations. S/he must be meticulous and have good organisational skills. Interest in paralegal work is welcome. S/he should be able to deliver high quality results and to propose creative solutions to problems.

We are looking for someone patient, positive and reliable. S/he must be able to work independently as well as to liaise closely with colleagues, pooling skills and ideas and sharing knowledge.

The working language of the unit is English. Good knowledge of French, German or another EU language would be an advantage.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- \bullet have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU^2
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG II. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\frac{\text{Commission Decision}}{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.
