## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

The 'Prosperity' directorate defines and implements Research and Innovation policy and investments to transform European society and industry. Our vision is to achieve a circular and regenerative EU industry for a prosperous, fair and healthy society.

The Industrial Transformation unit itself works towards a sustainable, fair and prosperous transformation of industries within this decade. The emphasis is on competitiveness, decarbonisation, circularity and sustainability.

We design and implement R&I policies and programmes and set related agendas to leverage private investment along the value chain and accelerate the development of safe and sustainable chemicals, advanced materials, and innovative industrial production including for coal and steel. To this end, we mainly collaborate with Member States, associated countries, industries, research and technologies institutes and civil society organisations. The unit is also in charge of preparing relevant legislation, when it is necessary.

Our priorities are in particular:

- Preparing an Advanced Materials Act, including the impact assessment, within the framework of the implementation of the Commission Communication on Advanced Materials for Industry Leadership from February 2024, and in line with the Political guidelines set by the President for this Commission.
- Steering the technical programming of the Research Fund for Coal and Steel (RFCS) and preparing future reforms of the legislative framework on RFCS.

### WE PROPOSE

An interesting administrative assistant position in a dynamic unit supporting colleagues on various daily administrative tasks in tandem with the other administrative assistant to the unit. The unit is composed of a multidisciplinary, highly motivated team with a very good, friendly and cooperative



working atmosphere, enabling everyone to give his/her best within a high-performing team. The colleague will have an opportunity to demonstrate high levels of proactivity and coordination through a wide range of tasks and functions within the core activities of the unit, contributing to its smooth running:

- Providing daily administrative support to the policy officers through dedicated EC tools for the efficient and effective functioning of the unit, by coordinating task allocations as well as tracking and following up on deadlines.
- Providing information and document management services within the unit and ensuring timely and appropriate follow-up by policy officers, including the handling of stakeholder correspondence and the management of functional mailboxes.
- Providing mission planning and support services.
- Backing-up the Head of Unit assistant.
- Assisting in conference and event organisations.

### WE LOOK FOR

We look for an experienced, highly motivated and well-organised colleague who enjoys teamwork. Good knowledge of informatics tools is an asset. Significant experience in administrative work is welcome.

We expect the new colleague to:

- have very good oral and written communication skills, in particular in English;
- work effectively with colleagues across the organisation and at all levels;

- demonstrate sound judgement and an ability to identify potential issues and propose solutions.

## 1. Selection

## > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $\ensuremath{\text{EU}^2}$
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

## > What about the selection steps?

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG II.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
