STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The European Personnel Selection Office (EPSO) is responsible for providing professional staff selection services on behalf of the Institutions of the European Union. Its mission is to attract and select talented individuals from across the EU through effective, fair and transparent selection procedures. As part of its ongoing efforts to enhance its role as a matchmaker between EU institutions and candidates, EPSO has undergone a business modernisation and transformation process.

The vacant post is in the newly created Test Development and Delivery unit. Its core mission is to contribute to an optimal organisation of work for implementation of the planning of competitions and selections as approved by EPSO's Management Board. This entails proposing the most suitable tests and test methodologies for the needs of the client institutions, including the entire test development process and taking all necessary steps in view of test delivery. The unit is furthermore responsible for managing external and internal partnerships related to test development and/or delivery as well as for Certification exams and the assessment of third-language proficiency.

The Psychologist team for which we are seeking an experienced Psychologist plays a key role in test content establishment, monitoring, quality control and training for different parties in the process.



WE PROPOSE

The European Personnel Selection Office (EPSO) is seeking to hire a qualified psychologist to join our team.

We propose an interesting and stimulating position in a diverse team of Psychologist. The successful candidate will play a vital role in the test content development and in particular in quality assurance.

The ideal candidate will support the test design process and put particular focus on psychometric and data analysis.

S/he will work very closely with diverse teams of psychologists, test developers, trainers, selection board members and other stakeholders. Furthermore, s/he will also need to present psychometric analysis and statistics to different stakeholders and give trainings in the area of expertise.

WE LOOK FOR

The ideal candidate will possess a university degree in psychology, substantiated by at least three years of dedicated experience in assessment development, quality control, and stakeholder collaboration.

Domains: STATISTICAL ANALYSIS of DATA and ADVICE

- Ability to understand and apply a wide range of psychometric theories, including classical test theory (CTT), item response theory (IRT), and Rasch models.
- Good understanding in statistical methods such as regression analysis (univariate and multivariate), ANCOVA, factor analysis, and automated scoring techniques.
- Understanding of fairness and bias analysis principles, including awareness of differential item functioning (DIF) and adverse impact.
- Familiar with software tools commonly used in psychometrics and statistics (e.g., R, Python, SPSS).
- Basic understanding of machine learning and AI concepts, including applications of natural language processing (NLP) and large language models (LLMs).
- Skilled in interpreting and communicating complex quantitative data for both technical and non-technical audiences.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in **English** and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
