### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### **WE ARE**

The Human Resources and Security Directorate General (DG HR) oversees recruitment policy, training and career management, social policies and working conditions for Commission staff. It is also responsible for keeping buildings and employees safe and secure, making sure that work continues during crises and dealing with online security.

Unit HR.04 plans and coordinates the evolution of the corporate HR Information Systems, notably SYSPER (internal IT tool). We ensure these solutions align with the Commission's HR strategic vision and values.

We are a professional, friendly and welcoming team committed to making the HR strategy a reality. With a diverse range of talents and expertise, we foster an inclusive and cooperative work environment. Joining our unit means becoming part of a collaborative team, where colleagues strive to make a positive impact on EU Institutions and are prepared to go the extra mile to deliver results.

Acting as the primary liaison between DG HR and DIGIT (Directorate-General for Digital Services), we oversee joint planning for IT development in HR policy areas. Additionally, Unit HR.04 manages relationships with various stakeholders, including business units within DG HR and other members of the HR Family, such as a growing number of EU institutions and agencies utilising the Commission's HR solutions.

Furthermore, the unit plays a pivotal role in the HR Digital Transformation programme. This programme seeks to revolutionise the Commission's current HR IT landscape and that of its partners. This ambitious transformation aims to establish an HR IT platform that will spearhead the implementation of the HR Strategy.



#### **WE PROPOSE**

To support the unit's work, we are looking for an IT Business Analyst who will contribute to the evolution and the transformation of the HR IT landscape.

In line with the objectives set in the HR Strategy, she/he will contribute to the implementation of IT projects for current and future HR IT platform and applications. In addition to coordinate with stakeholders from the EU Organisations, the IT Business Analyst will work closely with business units in DG HR (owners of different HR IT solutions) and DIGIT (responsible for the technical operations).

The person appointed will work with a dynamic team, focused on delivery, smooth collaboration and service orientation.

The list of possible tasks is:

- Analyse how the HR processes, definitions, principles, practices are implemented by the different EU organisation with a view of supporting the use of the HR IT platform.
- Identify viable business solutions, translate them into technical specifications and assist with their technical implementation.
- Define use cases and test scenarios on different technical environments.
- Support the change management process and analyse change requests to meet business requirements.
- Develop and deliver business-oriented documentation, training and coaching sessions.
- Analyse business processes and propose options implementation and for automation/ simplification in line with the capabilities and standards offered.
- Provide second level support for business and functional inquiries.
- Initiate and contribute to projects and continuous improvement initiatives.
- Interact with multiple stakeholders inside the DG, with the rest of the HR family, with DIGIT and with other EU organisations.
- Assist with the design of targeted modules of the HR Transformation programme, which is partly developed using ServiceNow.

### **WE LOOK FOR**

We are looking for a successful candidate with a strong IT background and experience as business analyst with at least three years of professional experience in a position with similar duties and domain would be an advantage

Required experience:

• Technical knowledge, skills, and experience in interacting with users of IT systems and IT developers.



- Knowledge and/or keen interest in Commission's human resources rules, processes and tools.
- Capacity to understand interdependencies between technology, operations and business needs
- Advanced drafting skills, including technical drafting and presentation skills.
- Strong analytical capacity and solution-oriented thinking.
- A high sense of responsibility and strong service orientation.
- Very good communication skills, with ability to analyse and structure complex information.
- High degree of planning and organisational skills, able to prioritise and manage multiple files and deliverables.
- Good interpersonal skills, working well both independently and in a team-oriented, collaborative environment.
- Very good command of spoken and written English equivalent to minimum level C1 and knowledge of French would be an advantage.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

# 1. Selection

# > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <a href="EPSO CAST">EPSO CAST</a> data base.

### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

# What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

## Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG III.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with  $\underline{\text{Commission Decision}}$   $\underline{\text{C(2017)6760}}$  laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 years.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
