STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE PROPOSE

We are excited to offer an engaging and challenging position that provides support to a welcoming and dynamic unit. In this role, you will act a bridge between business and technology and will be responsible notably for coordinating with Business Owners to identify needs, translating requirements into product specifications, planning and designing product roadmap, prioritizing product features and communicating to the various stakeholders of the evolution of the product and the related programmes and projects

The duties of the Business Implementation Manager include:

- Create and manage long-term goals and product roadmap
- Prioritise product features and oversee implementation plans and monitoring budget, risks and issues
- Ensure stakeholders acceptance and contribute to managing business transformation through involvement on design, functionality, testing, change and release management.
- Contribute to planning of the project and reporting on project state of play, risks and issues, changes and actions.
- Oversee and manage the implementation of HR products from beginning to end
- Assist business owners, project managers and other stakeholders to ensure that IT solutions correspond to business needs and are elaborated in line with the HR architecture and governance
- Identify issues related to project management, architectural technical design of the solution.
- Ensure the alignment of the project with horizontal activities (Data Protection, IT Security, Change management).
- Support events, meetings, collaboration calls with stakeholders.
- Contribute to the overall inter-institutional HR Transformation programme (HRT) and projects planning and milestones definition.

WE LOOK FOR

A dynamic and motivated colleague with a broad vision, a strong IT background and an appetite for project management. The candidate should have:

- Proven experience in IT development projects as project manager, or product manager.
- Proven experience in working in definition of business requirements of systems as business analyst, product owner or business manager.

- Experience with project monitoring and tracking tools.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Oualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels.**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> <u>C(2017)6760</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 years.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
