STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of Unit EMPL.G.4 "Financial Implementation and Procurement Centre" is to contribute to the sound and efficient management of the financial resources of DG Employment, Social Affairs and Inclusion in direct and indirect management. The unit is composed of 47 staff members in charge of financial activities, from the approved Financing Decision to the final payment, for both procurement, grants shared and indirect management.

WE PROPOSE

We propose a very dynamic position of Administrative Agent in a team dealing with several Funding programmes under the responsibility of DG Employment, Social Affairs and Inclusion.

The colleague will assist the Head of Unit and financial teams in the unit in planning, follow-up and timely execution of different activities as well as setting-up appropriate workflows and monitoring. Assist the Head of Unit in staff-related, administrative and organisation or logistics tasks. Ensure administrative support to the different terms of the unit in the follow up of financial procedures.

Also, the colleague will be integral part of the financial teams contributing to the verification that invoices and payments are financially and procedurally correct, that they are in conformity with the contract and the regulations, including documentation, data and figures. The colleague will also ensure coherence of financial data between different databases.

In more general terms, the post also will be contributing to assist the teams on the respect of financial, budgetary and contractual rules, procedures and deadlines (including call for tenders and programme / projects).



WE LOOK FOR

We look for a dynamic and motivated candidate with:

- a pro-active attitude towards problem resolution; excellent networking and client-orientation service:
- eye for detail and analytical capacity;
- strong sense of responsibility and the capacity to work autonomously, whilst at the same time being a good team player;
- knowledge about financial rules and procedures will be an asset.
- experience with the use of in the Commission is an asset.
- experience with the IT tools for grants management and administrative procedures of the European Commission will be considered an asset.

As regards languages, very good knowledge of English (written and oral) would be a clear advantage as well as a good knowledge of French.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:
 - 1. your CV 2. completed application form.

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels.**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG II. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\frac{\text{Commission Decision}}{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.
