STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the Directorate-General (DG) for Research & Innovation (R&I) is to design and implement R&I policies and programmes in collaboration with Member States, international partners, stakeholders and citizens. By mobilising relevant policy measures, such as R&I programmes, investments and regulations, the DG fosters the creation of new knowledge and game-changing innovation supporting the EU's priorities, notably the green and digital twin transition. The aim is to generate a high scientific, technological and societal impact, built on scientific evidence and relevant input from citizens.

Directorate H "Common Implementation Centre" (CIC) in DG for Research & Innovation designs the strategy and provides the framework for the coherent and simplified implementation of EU R&I programmes. It drives the digital transformation, harmonises project life-cycle management across the Commission and maximises synergies between EU programmes. It provides comprehensive services and advice on legal, audit, business process and IT issues, including on a corporate level – involving more than 60 EU funding programmes.

It provides support to Commission services in charge of the supervision of the executive agencies and the funding bodies implementing Horizon Europe. It plays a coordination role and promote a consistent approach among those services.



WE PROPOSE

Unit RTD.H.4 – Common Service for Executive Agencies & Funding Bodies in Directorate-General for Research & Innovation of the European Commission - is seeking to hire one policy officer – business intelligence analyst. We offer a stimulating and visible position, offering scope for initiative and creativity.

As a policy officer, you will participate in cross-cutting initiatives aimed at maximising the value, quality, and strategic use of data assets. You will play a crucial role in ensuring the successful delivery of data products, services and projects, as well as IT tools, and fostering a collaborative, client and data-centric culture.

In particular, the jobholder will contribute to:

- Defining and overseeing business requirements of different data and IT projects, ensuring timely completion, quality assurance and risk management.
- Contributing to the development of innovative solutions and digital services to enhance the delivery of data products and services.
- Communicating complex data services and data projects' concepts clearly and effectively, ensuring that stakeholders (like executive agencies and funding bodies) are well-informed and engaged throughout the service lifecycle.
- Establishing strong relationships with stakeholders, including within the CIC, with other commission services, executive agencies and joint undertakings.
- Representing the unit in inter-service and inter-institutional fora a relating to data and IT projects, ensuring alignment and knowledge sharing.
- The outreach activities carried out by the CIC, e.g., by taking part in working groups, brainstorming sessions, surveys, helping with ad hoc projects and providing ideas, comments and suggestions.

We are looking for a proactive, strategic, and well-organised professional with proven experience in data services management, business process management, and policy-oriented data analysis within a complex institutional environment.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions</u> <u>of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> $\underline{C(2017)6760}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
