STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Research and Innovation (DG RTD) is responsible for developing and implementing the European Research and Innovation (R&I) policy with a view to achieving the goals of Europe 2030 and the Innovation Union. DG RTD supports research and innovation through European framework programmes, coordinates and supports national and regional research and innovation programmes, contributes to the creation of the European Research Area and supports European organisations and researchers in their cooperation at international level.

RTD.H is the "Common Implementation Centre" (CIC) which designs the strategy and provides the framework for the coherent and simplified implementation of EU R&I programmes and other direct management programmes. It collaborates closely with the central services and other DGs to offer modern and streamlined services to the research family of the Commission. The CIC drives the digital transformation across the Commission to maximise synergies between EU programmes and strives for further harmonisation of project life-cycle management. It provides modern, comprehensive and high-quality services and advice on legal, audit, business process and IT issues to the entire research family. As the one-stop shop for data, reporting, and monitoring of the research framework programmes, it provides innovative solutions and knowledge to policy-making and stimulates the exploitation of results.

RTD.H.DEP.IT "Common IT Service" implements (in partnership with DG DIGIT) reliable, modern and high-quality information systems supporting the full cycle of Grant Management for all direct granting programmes and entities supported in the Commission. The Department has a corporate role in the provision of eGrants systems and services for the whole Commission. The Department is responsible for the development and maintenance of IT applications (eGrants suite) covering the complete grant cycle, from call definition and publication, to audits and programme evaluation, experts, external administrative staff and beneficiaries.



WE PROPOSE

We offer the post of Finance Agent in a committed and dynamic team within the Governance, Strategy and Resources sector of the IT Department, currently managing a budget of 55 million euro.

The successful candidate will be involved in providing financial support to the management of a large portfolio of service providers' contracts.

WE LOOK FOR

We look for an organised and motivated Financial Agent, who will be in charge of assisting with the management of a portfolio of service providers' contracts. The candidate will be in contact with the contractors and service providers. The work involves - submitting offer requests, preparing commitment/ payment/ recovery order files, etc.

The successful candidate should convincingly demonstrate his/her versatility and resilience, solution-oriented and positive attitude to his/her diverse responsibilities and being able to meet deadlines. We would very much welcome a professional with a solid administrative and financial background. Proven experience in the field of programme and financial management, as well as being at ease with IT tools, including Excel, ABAC ASSETS and SUMMA, is a must. The successful candidate should demonstrate team spirit, flexibility, reliability, good organisational and communication skills.

The main working languages are French and English.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:
 - 1. your CV 2. completed application form.

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Oualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG II.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\underline{\text{Commission Decision}}$ $\underline{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
