STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG Trade and Economic Security is responsible for leading the EU's common commercial policy, one of the European Union's exclusive competences. Trade policy plays a critical role in enhancing the EU's economic competitiveness, shaping globalisation, and defending the EU from unfair trade practices and threats to its economic security. Directorate G of DG Trade and Economic Security manages Trade Defence Instruments (TDI): anti-dumping (AD), anti-subsidy (AS), and safeguards. These are key tools to ensure trade remains fair to uphold the EU's commitment to open markets and free trade. Within the unit TRADE.G.1, the sector "Policy and WTO Relations" is in charge of general policy on TDI, WTO relations and relations with third countries, and ensuring, the consistency of horizontal legislative initiatives and internal decisions with relevant EU and WTO legislation and jurisprudence.

WE PROPOSE

The unit is seeking to hire a Secretary.

The position will consist of varied responsibilities in a friendly and cooperative working environment with excellent team spirit across the two sections of the Unit. The successful candidate will work as a secretary in the 'Policy and WTO Relations' section, composed of a young, dynamic and motivated team of 11 colleagues. Working in a three-person secretariat of the unit, she/he will support the manager of the section and carry out logistical and administrative tasks. This will involve daily secretarial support, such as organising meetings, filing and archiving documents, and organising missions. The selected candidate will also be asked to do research on various topics for the team. Additionally, the successful candidate will also handle confidential files and assist the policy officers with the standard procedures related to sending sensitive notes, letters, reports and other correspondence. The candidate may also be asked to replace the other secretaries in the Unit, as well as the Director's secretary, in case of absence.



In view of the specific requirements needed for the job, DG Trade provides a mandatory two-week introduction course for new officials in Directorate G, and several other internal courses tailored to the needs of TDI staff.

WE LOOK FOR

We are looking for a dynamic and well-organised secretary capable of working both as part of a team and independently. The successful candidate should have a high sense of initiative, responsibility, and discretion, as well as excellent interpersonal and organisational skills. The candidate should have very good written and oral communication skills in English. Knowledge of Chinese would be an asset. Practical knowledge of the Commission's administrative procedures and IT tools (DECIDE, ARES, MIPS, SYSPER, BASIS, LEGISWRITE, ePOETRY, V-PASS) is a clear advantage. Flexibility in the working hours is also required.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
