STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

LINGUIST AGENT

WE ARE

DGT.A.1.BG.1 is one of the two units in the Bulgarian language community in Department DGT.A.1 (Bulgarian, Italian and Maltese) of the Directorate-General for Translation of the European Commission (DGT).

DGT is the domain leader for all translation-related work in the Commission, and a reference in the world of translation. It contributes to the development of advanced data-driven language technologies, to the digitalisation of multilingual systems and processes, and to the modernisation of the translation profession.

Based in Brussels, our unit provides the Commission's Directorates-General and Services with high-quality translations in Bulgarian on a wide range of subjects and policy areas.

Currently, the unit consists of 22 translators and 4 assistants.

We are an entirely Bulgarian speaking unit, but we use English and French in our daily contact with our colleagues from the horizontal units within the DGT and from other DGs.

WE PROPOSE

Unit BG.1 of DGT is seeking to hire one linguist agent.

The position will consist of traditional secretarial and administrative tasks in combination with handling of files for outsourcing, processing and formatting documents, communicating with translation requesters and colleagues both inside and outside the DGT by telephone, e-mail and other communication channels, using specific IT tools relevant to the DGT and generally supporting the work of translators and the head of unit.



The successful candidate will join a friendly and dynamic team and will work in a predominantly Bulgarian-speaking environment.

The successful candidate will be able to profit from a vast and well-organised training programme, particularly in the field of IT and language technologies.

WE LOOK FOR

We are looking for a very well organised, dynamic and flexible person with good communication skills and a service-minded attitude. The successful candidate should have IT proficiency and curiosity, be a quick learner and have very good organisational skills. They should be able to integrate into the team but also to work autonomously and under pressure when needed.

A high level of spoken and written Bulgarian is essential; very good knowledge of English is also required, and knowledge of French would be an advantage.

The successful candidate will be working as part of a small team of assistants, and in close collaboration with the translators.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of Bulgarian
- a satisfactory knowledge (minimum level B2) of English language.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority². If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the <u>Conditions of Employment of Other Servants</u>, the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in Bulgarian and English.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group AST/SC.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1**st **contract will be up to 4 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
