STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit FISMA.A5 "Economic analysis and evaluation" provides the analytical input and economic advice to facilitate the development and implementation of policies in EU financial services. As a unit in the horizontal, coordinating Directorate of DG FISMA, we contribute to the DG's priority initiatives in the area of capital markets, banking and insurance and help shape policies on retail finance, sustainable finance and digital finance. We are the DG's contact point for better regulation, thereby helping the EU deliver evidence-based policies and laws that achieve their objectives in the most efficient way, while being tailormade to the needs of EU citizens, businesses, and civil society. We assess the need for and impact of new regulatory proposals and other policy initiatives and evaluate the effectiveness of the rules in place. The aim is to ensure that DG FISMA's policies are effective, coherent, evidence-based and underpinned by economic arguments, while contributing to the Commission's priorities.

We analyse financial market developments, coordinate the DG's centre of expertise for data, and are in charge of various projects to advance data-driven regulation and supervision. We also maintain the link to think tanks and academia and participate in various EU and international fora, such as the Risk Standing Committee and Data Standing Committee of the European Securities and Markets Authority, working groups of the Financial Stability Board, the Research Group of the Basel Committee, and the Regulatory Oversight Committee.

WE PROPOSE

We offer a professionally rewarding position in a highly competent and motivated team of (mostly) economists that will allow you to monitor financial markets and help inform policy-making in EU financial services. Due to our involvement in all key policy areas, our team is in a unique position to see the big picture and work directly on priority files. We work closely with all units in the



Directorate and in the DG and provide substantive economic and analytical input also directly to senior management. The successful candidate will assist the unit's work in managing relevant data, developing indicators, preparing data tables and visualisations, and conducting quantitative analysis to inform policies, including those needed to build a European Savings and Investments Union. S/he will monitor financial market developments, including the emergence of new technologies and financial instruments such as crypto assets, provide data analysis to inform policy development in the DG and contribute to the DG's annual flagship European Financial Stability and Integration Review. The job also includes database management and acting as liaison with external data providers and other statistical assistants in the Commission.

WE LOOK FOR

We look for a person with a strong motivation for a career in the area of financial markets analysis and evidence-based policy-making in financial services. The successful candidate should:

- have an educational or professional background in statistics, economics, finance and/or IT or similar
- have a good notion about data treatment and/or analysis
- have good analytical, problem-solving and drafting skills
- be familiar with some statistical software tools and programming languages (preferably R)
- be proactive
- be a team player who can take initiatives, but also able to work autonomously, and be resilient. Familiarity with relevant databases and experience in data analysis in the area of financial markets is an advantage.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Oualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

Lariguages

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, in function groups AST.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C (2025)4716. Higher grades may be granted exceptionally.

The duration of the **1**st **contract will be of 1 to 4 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with <u>Commission</u> <u>Decision C(2025)4716</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
