STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Our unit is composed of 37 people from different nationalities and has the responsibility to manage DG AGRI's external communication policy with a view to getting our messages across to the general public, stakeholders, media and colleagues. Our activities include a broad range of communication and information actions in relation to the external public (fairs, web, conferences, events, electronic publications, social media as well as providing grants to external groups who act as information multipliers to the general public and the agricultural world).

The unit also deals with the support the European agricultural sector by promoting EU agricultural products on the internal market and in third countries through organising and co-financing promotion actions and developing economic agri-food diplomacy with activities such as information campaigns and high-level missions to raise the awareness about the qualities of such products.

WE PROPOSE

A secretary post within a dynamic environment, part of a two-person secretariat support team.

The position involves various administrative and secretarial tasks, administrative support and organisation for the Head of Unit and deputy Head of Unit, task assignment and monitoring within the unit. It offers a wide range of tasks (handle incoming mails, preparing routine correspondence, launching and responding to ISC, briefings, PQ, missions, filing and archiving). The function requires an aptitude for interpersonal relations with the team, excellent coordination skills, and an efficient follow-up of deadlines. It also requires a certain degree of autonomy, but always in close collaboration and interaction with the Head of Unit and the deputy Head of Unit.

WE LOOK FOR

We are looking for a secretary with high sense of responsibility, service-oriented approach and dynamic personality. Adaptability is required. S/he should be motivated, able to organise her/ his work and work both autonomously and in a team. Good planning, attention to detail, the ability to adjust priorities are critical as well as a positive and a people-oriented attitude. The successful candidate should have practical knowledge of the Commission's administrative procedures, as well as IT tools such as: ARES, Eurolook, LegisWrite, MIPS, SYSPER, BASIS, DECIDE (CISNET), e-Greffe.

A good command of English and French is required and further knowledge of other languages would be an advantage.

Experience in web and communication tools will be appreciated.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Oualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- $^{\bullet}$ have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU^2
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the <u>Conditions of Employment of Other Servants</u>, the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, in function groups AST/SC.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1**st **contract will be up to 4 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
