## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The Directorate-General for Communication is the corporate communication service under the responsibility of the President of the European Commission. We promote and support the political priorities of the Commission and contribute to bringing Europe closer to citizens. We also manage the Commission Representation offices in the Member States.

The Directorate D "Communication support services" supports the achievement of objectives by ensuring effective budgetary and financial resources management, procurement and grant support, internal control, health and safety, information technologies and document management for the European Commission Representations and for the Headquarters in Brussels.

The sector COMM.D1.002 Strategic Planning, Evaluation of Communication and Research is responsible for leading DG COMM and the Communication network in monitoring and assessing the performance of communication activities. The sector is also responsible for coordinating DG COMMs Strategic Planning Cycle, including annual management plans and activity reports.

The sector consists of a small but dynamic team who manage many different types of tasks, from advising in the design and implementation of communication activities, data management and analysis, project management, and managing the Framework Contract for Evaluation Studies.

The duties and tasks of the team are constantly evolving, requiring good organisational capacity, adaptability and a strong drive for continuous learning.



## **WE PROPOSE**

---

Unit D.1 of DG COMM is seeking to hire a statistical assistant to participate in the conception and implementation of various projects including:

- Supporting communication teams in designing and implementing communication performance monitoring and assessment systems.
- Analysing, synthesising communication performance data with a view to draw actionable conclusions and recommendations.
- Ensuring quality control of deliverables provided by external contractors as part of evaluation projects.
- Advising on sound statistical methodological approaches to continuously improve DG COMMs capacity for evidence-based decision making.

The successful candidate will work on a number of different tasks, with a high level of independence and room for creativity in reaching their goals. The jobholder will be expected to be able to work across the team, different units and directorates in order to successfully implement projects.

## **WE LOOK FOR**

---

We are looking for a motivated and dynamic Statistical assistant.

The ideal candidate should have:

- sound knowledge of / experience with data management and analysis,
- communication evaluation methodology and the promotion of a results-oriented performance culture in the external communications field, notably as regards the use of indicators, setting benchmarks and data visualisation/presentation,
- academic background or professional experience in research (preferably in communication, sociology, economics) and/or data science/quantitative research methods is essential,
- good knowledge about the structure, priorities and working methods of DG COMM, in particular the Representations in Member States will be considered an asset,
- strong communication and interpersonal skills, who can work autonomously and as part of a team,
- good analytical skills and a sound background on data analysis,
- excellent organisation and prioritisation skills,
- strong sense of initiative as well as good interpersonal skills and strong client orientation.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
