STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The newly created Health Emergency Preparedness and Response Authority (HERA) which is established as a Directorate-General of the European Commission.

The HERA shall assist the Commission to improve preparedness and response to serious cross-border threats in the area of medical countermeasures, in particular:

- strengthening health security coordination within the Union involving all relevant actors during preparedness and crisis response times and bringing together the EU Member States, industry and relevant stakeholders in a common effort;
- addressing vulnerabilities and strategic dependencies within the Union related to the development, production, procurement, stockpiling and distribution of medical countermeasures;
- contributing to reinforcing the global health emergency response architecture.

The HERA shall be responsible for the following tasks which shall be exercised in close cooperation with the Member States:

- assessment of health threats and intelligence gathering relevant to medical countermeasures;
- promoting advanced research and development of medical countermeasures and related technologies;
- addressing market challenges and boosting the Union's open strategic autonomy in medical countermeasures production;
- swift procurement and distribution of medical countermeasures;
- increasing stockpiling capacity of medical countermeasures;
- strengthening knowledge and skills in preparedness and response related to medical countermeasures.



HERA.02 is the unit in charge of Intelligence Gathering, Analysis and Innovation. The unit lays the foundations for structured and targeted pandemic preparedness and response planning in area of medical countermeasures (MCM) by developing and strengthening intelligence gathering systems and activities, including the development of IT tools, whose inputs will inform and guide HERA's action in identifying, assessing and addressing serious cross-border health threats. To this end, this unit aims to promote research, innovation and development of medical countermeasures able to prevent, detect, and rapidly respond to health emergencies.

WE PROPOSE

We propose a position in the Unit in charge of i) assessment of health threats and intelligence gathering relevant to medical countermeasures; and ii) promoting advanced research and development of medical countermeasures and related technologies. The job holder will contribute to the implementation of the MCM strategy on these aspects. The jobholder will notably gather intelligence on HERA's priority health threat, in particular on scenarios to prepare against, MCM needs, MCM landscape and MCM pipeline, as well as on ongoing interventions in support of MCM innovation and access. They will contribute to the identification of gaps and prioritisation of interventions to be implemented by HERA along the whole MCM lifecycle (including innovation, manufacturing, purchasing, marketing, stockpiling).

These tasks will be exercised by desk research as well as active information requests and exchanges with a broad range of stakeholders. The job will be focused on high priority threats for HERA, namely viruses with pandemic or epidemic potential listed in the MCM strategy, and AMR pathogens.

WE LOOK FOR

We are looking for a highly motivated and skilled colleague to join our team. As a policy officer, you will play a critical role in supporting the intelligence gathering and innovation functions. The job requires ideally a combination of scientific and policy background and experience. Excellent communication skills both oral and written in English are essential. It will be key to have the ability to understand the health crisis and preparedness domain related to the priority threats of HERA. It will also be essential that you are able to interact with high-level scientific and technical experts, and to translate scientific or technical outputs into policy recommendations for decision making to support availability and accessibility of MCM, including in relation to funding.

The candidate should have the following skills:

- Prior experience and/or sound understanding of health threats
- Prior experience on MCM path to market, including vaccines, therapeutics, diagnostics, medical devices and personal protective equipment.
- Understanding the processes of data collection and analysis in relation to health threats and medical countermeasures



- Knowledge on modelling of health threats in view of assessing the impact of MCM interventions would be an asset
- Combined experiences and qualifications in the medical, public health and veterinary domain would be an asset, in particular in relation with HERA priority health threats (viruses with pandemic or epidemic potential, AMR bacterial and fungal infections).
- Excellent organizational and time management skills, with the ability to handle multiple tasks and priorities.
- Problem solving and an ability to get things done, as well as a good eye for detail.
- Communication and interpersonal skills, with the ability to work collaboratively in a team environment.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:
 - 1. your CV 2. completed application form.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Oualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\underline{\text{Commission Decision}}$ $\underline{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
