STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Unit ESTAT C3 (statistics for administrative purposes) is the source for high-quality statistical services needed to develop, implement and evaluate policies relating to the EU's GNI own resources, and remunerations and pensions of EU staff.

The GNI team is responsible for ensuring the reliability, comparability and exhaustiveness of National Accounts data which are provided for EU GNI/VAT own resources purposes, thereby improving the overall quality of National Accounts data.

The GNI own resource is a uniform percentage rate applied to the GNI of each Member State. It has become the largest source of revenue and today accounts for around two thirds of total EU revenue. The GNI Regulation establishes the procedures to facilitate the verification, and where necessary the improvement of the comparability, reliability and exhaustiveness of Member States' estimates of gross national income (GNI).



WE PROPOSE

The GNI team, in charge of GNI statistics used for own resources purposes, is seeking to hire a Statistical Officer (contract agent). The successful candidate will work on:

- verification of sources and methods used to calculate GNI by Member States for EU own resource purposes and follow-up of reservations related to the quality of Member States GNI data,
- verification of the data transmitted in the annual GNI Questionnaires and the Reports on Quality by Member States for EU own resource purposes concerning the statistical sources and the procedures for calculating GNI and its components,
- contribution to the methodological projects on GNI related issues.

The job involves a mixture of autonomous work and teamwork. There is also some travel foreseen during specific periods.

WE LOOK FOR

We are looking for a motivated colleague who is interested to learn and develop in the field of the GNI verification. The candidate should have a solid background in economics and/or statistics. We are looking for strong analytical, problem-solving, and sound judgment skills. Knowledge of national accounts would be considered as a strong asset.

The job requires a strong sense of initiative, flexibility and very good organisational and communication skills. The candidate should be able to communicate effectively to different audiences, both in writing and orally. Team spirit and a results-oriented approach are also important as well as the ability to work independently against tight deadlines. Good command of English is required. Additional language skills are further assets.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
