STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union (EU). Eurostat's mission is to provide high-quality statistics and data on Europe. Eurostat co-ordinates statistical activities at EU level and more particularly inside the Commission.

Eurostat Unit F1 'Social indicators: Methodology and development; Relations with users' mission is to foster progress in European social statistics by providing advice, services and support for an efficient and responsive integrated statistical architecture.

We ensure development and dissemination of population projections as well as several transversal social indicators covering the European Pillar of Social Rights, culture, and sports, among others. We oversee strategic projects for Eurostat and for the Commission dealing with flash estimates of income distribution, joint distribution of income, consumption and wealth and reconciliation of these dimensions between survey data and national account data. The Financial Cell of the whole Directorate F 'Social statistics' is part of the Unit.

WE PROPOSE

We are seeking to hire a secretary to the Unit (contract agent). The position will consist of providing assistance and support to the Unit in a of a variety of secretarial, administrative and organisational tasks. This includes preparation and organisation of business travel and meetings; support related to human resource management (e.g. absences, worktime, training, recruitment); following up on briefing requests; document management support, document editing and operational support to the teams as necessary. The secretary works also as a back-up for other units at the directorate if needed.

Eurostat will provide training or other support to get acquainted with the tasks.

WE LOOK FOR

We are looking for a person with an administrative background. Previous experience in a public administration would be an asset. Ability of communicate orally and in writing to various interlocutors (inside and outside the Unit), autonomy, organisational skills, care for deadlines and sense of service are among the qualities which would be appreciated. We expect a good command of the usual software and IT working tools. Previous working experience in the Commission and knowledge of its working tools (ARES, MIPS, DECIDE, etc.)/procedures is an advantage.

A good knowledge of English is necessary to success in the job.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG II. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 years.** Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
