#### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

The 'Data, Artificial Intelligence & Web' unit (DIGIT.B.1), in collaboration with other Commission services and stakeholders, provides high-quality services and expertise in data analytics, artificial intelligence, and web presence to support the European Commission's operations and strategic activities. This effort enhances efficiency through information sharing, interoperability, integration, and standardisation, facilitating the Commission's Digital Transformation and the implementation of EU policies. In the realm of external web presence, DIGIT.B.1 is the service provider for the EUROPA Web Platform, comprising the Europa Web Publishing Platform, Europa Community Platform SaaS, Webtools, Europa Component Library, and Open Europa Library.

#### **WE PROPOSE**

Unit B.1 of DIGIT is seeking an IT Service Officer - Service Manager to support its activities, particularly focusing on the Europa Web Platform and its services, including implementation, hosting, and technical support for multiple Drupal websites.

This role is crucial in project and service management, information management, quality assurance management and technical support. It involves coordinating project planning, workload management, and stakeholder relations, technical team management.

The officer will manage teams handling critical platforms, that have a high number of visitors as well as users. The person will provide guidance to the team on security, code quality and performance of other applications. Additionally, she/he will address operational needs, such as administrative procedures and logistical tasks related to onboarding and offboarding resources. The officer will ensure optimal performance in project delivery, service enhancements, stakeholder communication, and staffing procedures.



#### **WE LOOK FOR**

We look for an experienced, extremely well-organised and responsible colleague to contribute to the objectives of the unit and its sectors (e.g., Europa Web Platform). The varied and interesting work requires high motivation, high initiative, eagerness to learn, team playing capacity but equally capacity to work autonomously.

The ideal candidate should have:

- A level of education corresponding to completed university studies of at least four years in IT domain, attested by a diploma.
- At least three years' experience in IT Project Management or IT Service Management.
- At least three years' experience in leading central quality assurance technical teams in charge of multiple projects.
- At least three years' experience with managing ci/cd pipelines.
- At least ten years' experience integrating Opensource technologies.
- At least two years' experience in coordinating designing, implementing and managing shared pipelines. used by more than 100 applications.
- At least two years' experience in managing applications with multilingual support for several languages (more than 5 languages).
- Good organisational skills and an ability to work accurately with a critical eye for detail.
- Stakeholder management.
- Perform code review.
- Drupal knowledge is considered an advantage.
- Project Management certifications are considered advantageous.
- Excellent oral and written communication skills in English (C1).

The main working language of the unit is English.

# 1. Selection

# Am I eligible to apply?

# You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Oualifications:**

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

## What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the <u>Conditions of Employment of Other Servants</u>, the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

### 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

# > Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function groups AD**.

#### Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1**<sup>st</sup> **contract will be up to 4 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with <u>Commission Decision C(2025)4716</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
