## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

---

DG HR.B.2, sector 1, is responsible for managing selection, mobility and recruitment processes for non-management officials and temporary agents in Brussels. The sector is located in Brussels and team members handle the publication of vacancy notices, selection follow-ups, recruitment of officials and temporary agents, as well as the related sub-processes. We ensure the smooth operation of policies and legal matters related to these processes. Sector 2 focuses on horizontal tasks such as job descriptions, job quota movements and re-organisations, while our colleagues in sector 3, located in Luxembourg, take care of interinstitutional transfers and end of service, amongst others.

#### WE PROPOSE

---

Unit HR.B.2 (sector 1) proposes an exciting opportunity as a HRM Agent, focusing on Selection, Recruitment, and Mobility of Officials and Temporary Agents. Although this job primarily focuses on processes related to **DG BUDG**, the jobholder may have to back-up for other client services. You will join a friendly team that values mutual support, ensuring a positive work environment. In this role, you will be responsible for liaising with HR Correspondents and recruiting line managers from our client DGs, and acting as a contact point for personnel issues. You will also manage document conservation, support budgetary follow-ups and assist in reimbursement procedures for candidates.



## **WE LOOK FOR**

---

Unit HR.B.2 is looking for a highly motivated, proactive and well-organised person with a strong sense of responsibility and client orientation as well as a great team spirit and very good communication skills. The ideal profile for the job would include at least two years of relevant professional experience in Human Resources or closely related functions. Proficiency in English (C1) is required. Knowledge of French is considered an asset.

The ideal candidate will possess a mix of skills and experience to effectively navigate and execute HR-related processes at our organization and should have experience managing stakeholders effectively and ensuring comprehensive administrative follow-up within HR-related activities. A good understanding of the EU Staff Regulations (SR) and Conditions of Employment of Other Servants (CEOS) is key, particularly as they apply to HR processes. Familiarity with the IT tools used in DG HR - such as Sysper, ARES, AGM, Teams, and SharePoint - is an asset. An openness to digital advancements, including AI, will support the integration of innovative solutions into our HR processes.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least :

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
