In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

## WE PROPOSE

---

DIGIT CERT-EU is seeking to hire a truly motivated Detection Engineer with experience in finding, creating, reproducing and analysing high-risk attack path which could, if exploited, lead to substantial impact in various heterogeneous network architectures.

The primary purpose of this role is to work with other Detection Engineers, DFIR experts and SOC analysts to:

- Create, test, and maintain detection rules to detect malicious activities.
- Contribute to the lifecycle of detection rules in our detection-as-code.
- Collaborate with threat intelligence and incident response team to turning emerging threats into effective detection rules.
- Continuously improve detection rules quality by reducing noise in close collaboration with our



SOC team.

- Conduct Purple Team engagements with Union entities, crafting TTPs and matching detection rules.
- Conduct in-lab threat emulation to validate detection coverage and contribute to automated regression testing.

## **WE LOOK FOR**

---

We are looking for a candidate who will demonstrate some of the following required skills and characteristics:

- Experience in writing detection rules at scale using a detection-as-code approach.
- Experience working with continuous integration and continuous delivery (CI/CD) pipelines.
- Experience with any public cloud or on-premises SIEM platforms.
- Knowledge with macOS, Linux, and Windows operating systems.
- Experience in authoring detection rules and documenting investigation notes.
- Experience with Python and other programming languages.
- Experience with offensive security activities is a plus.
- Experience in incident response is a plus.

The ideal candidate will possess some, or all, of the following:

- A university degree in IT and at least 3 years of hands-on professional experience in IT Security.
- Work experience within a MSSP-like environment.
- A high level of customer orientation.
- Strong analytical and problem-solving skills, including the ability to deal with a large amount of information in a limited time.
- Ability to establish and maintain effective working relations with coworkers in an international and multi-disciplinary work environment.
- A high degree of commitment and flexibility.
- Work experience in a complex public sector environment.
- Excellent communication skills in English, both orally and in writing.
- Experience in delivering trainings and public presentations.
- A focus on constant learning and improvement of technical and personal skills.
- Experience with a vast array of IT technologies and the ability to quickly master new ones.

The candidate must hold a security clearance at EU SECRET level or be in a position to be security cleared.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in **a single pdf** in the following order:
  1. your CV
  2. completed application form.Please send these documents by the publication deadline to [secretariat@cert.europa.eu](mailto:secretariat@cert.europa.eu) indicating the call for interest reference EC/2026/DIGIT/431172 in the subject.
3. Please note that completion of the application form is **mandatory**. Applications that are not fully completed will be considered incomplete and may not be reviewed.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission. Candidates will be required to undergo a security vetting that is conducted with the national administration of the Member State.

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
