STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Employment, Social Affairs and Inclusion (DG EMPL) pursues policy, legislative and financial initiatives designed to build a highly competitive social market economy in the European Union. The unit provides policy analysis and advice and develops analytical tools, research actions and outputs that help design, implement and monitor just transition policies and instruments at EU and international levels, including the Social Climate Fund and the European Fair Transition Observatory, thereby contributing to a strong social dimension of climate, energy and environmental policies and the Clean Industrial Deal as well as of research & innovation policy.

WE PROPOSE

We are offering an interesting and rewarding position as Administrative & Financial Agent (Fair Green and Digital Transitions, Research) in a dynamic, friendly and diverse team responsible for shaping and implementing research & innovation actions and just transition policies.

The selected candidate will provide secretarial and administrative support to the Head of Unit, and the team more generally, including the attribution and monitoring of tasks and the handling of briefings, inter-service consultations, parliamentary questions, and access to document requests.



S/he will help ensure the smooth running of the unit, including the management of functional mailboxes and support to the organisation of internal and external meetings and missions, as well as relations with internal and external stakeholders.

Depending on the profile and interests of the successful candidate, s/he may also take an active role in HR issues and/or in financial programming and management, as back-up of the Financial Assistant to the unit. If needed, the candidate would be encouraged to follow related training courses.

WE LOOK FOR

We are looking for an open-minded, service-oriented, creative, flexible and resilient team player with very good organisation, communication and drafting skills and interested to take on a wide range of tasks and responsibilities in a dynamic, friendly, and inspiring work environment. Given the need to deal on a regular basis with internal and external stakeholders, tight deadlines and sensitive information, commitment, discretion and loyalty are essential.

S/he will have an interest in employment and social affairs, research and innovation, and/or green and digital transitions and appreciate engaging with internal and external stakeholders.

Sound and proven knowledge of MS Office applications, SharePoint and virtual meeting tools, as well as experience with - or willingness to learn/update/enhance - main document management and administrative tools and procedures are essential. Good knowledge of and/or interest in learning HR and financial programming/management tools and procedures are strong assets.

Proficiency in English (C1/C2) and good drafting skills are a huge advantage. Knowledge of French, German or other EU languages would be an asset.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the Conditions of Employment of Other Servants**, in **function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.
