In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

**Unit DGT.D.DE.3** is the sole unit of the German language department located in Luxembourg. It currently comprises 32 translators, one quality manager and 6 assistants.

The primary task of the unit is to translate documents from English, and occasionally from French or other official EU languages, into German.

Our translations cover a diverse array of subjects and policy areas, including health and food safety, trade, internal market and businesses, taxes and customs, employment and social affairs, budget, defence and several smaller domains. The team is known for its dynamic, cooperative approach and strong team spirit. We work closely with the two other units of the German language department to provide mutual support

### WE PROPOSE

The chosen candidate will translate Commission proposals for legal acts, autonomous Commission legal acts, and various other text types such as communications, reports, strategic papers, press releases, letters, consultations from the mentioned policy areas, as well as web content for the Commission websites.

Additionally, the translator will be involved in quality assurance, terminology work and the evaluation of outsourced translation projects.

After a suitable integration period, there will be an opportunity to specialise in one or more of the thematic areas handled by the unit

### WE LOOK FOR

We are seeking a motivated, dedicated and reliable colleague with excellent command of German, very good knowledge of English, and proficiency in a second official EU language, preferably French.

Expertise in areas such as health and food safety, trade, internal market and businesses, taxes and customs, employment and social affairs, budget, defence, or web translation as well as knowledge of additional languages would be advantageous.



We expect you to be willing to familiarise yourself with the subject areas handled by the unit and to adopt a flexible approach to any task you are assigned.

Lastly, you should be comfortable using translation tools and willing to improve your skills in this area.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

##### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

###### **General criteria:**

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

###### **Qualifications:**

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

###### **Languages:**

- German as mother tongue or equivalent level.
- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>.
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

## ➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in German, English and possibly in a third official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### ➤ Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the Conditions of Employment of Other Servants**, in **function group FG IV**. General information on Contract Agents can be found at this [link](#).

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 3 years**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
