## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE PROPOSE

DIGIT C.1 is seeking to hire one Finance and Contracts Officer - Procurement Operations Officer

The Procurement Operations Officer will provide support for designing, negotiating, documenting, implementing, evolving and documenting the contractual and administrative procurement frameworks underpinning the operations of the Software and SaaS Broker.

It requires setting up and managing contractual frameworks with software sellers and publishers, ensuring compliance with public procurement rules while supporting the operational model of the Software and SaaS Broker.

It also requires establishing and further developing communication and engagement channels with business stakeholders from the European Institution in order to collect and aggregate the business needs, as well as maintaining constructive working relationships with software sellers, publishers,



and relevant public stakeholders to support smooth cooperation and alignment with the Broker's and EUI objectives.

## **WE LOOK FOR**

---

We are looking for a dynamic individual with experience in the IT and Procurement domains, either an IT professional with relevant procurement expertise, or vice-versa.

The ideal profile for the job is a professional with at least 5 years of demonstrated experience in setting up, negotiating, and managing procurement contracts and contractual frameworks in the IT domain. Including for instance interacting with service and solution providers and multiple stakeholders, conducting negotiations, coordination activities, and the aggregation of downstream needs for establishing a common negotiating approach and objectives.

Knowledge in the below domains will also be considered an advantage during the selection process:

- at least 2 years in working with IT-related procurement contexts, including software, SaaS, or digital services, and the ability to understand how contractual terms support technical, operational, and service delivery requirements;
- At least 1 year in interacting with service and solution providers and multiple stakeholders across institutions or services, conducting negotiations, coordination activities, and aggregation of downstream needs for establishing a common negotiating approach and objectives;
- at least 1 year in maintaining structured repositories of contractual or administrative documentation, ensuring information accuracy, traceability, and accessibility for operational and audit purposes.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

#### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
