STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DIGIT.C.5 supports the Commission's Digital Workplace (DWP) by delivering IT tools and services to all staff. Key services include:

IT Helpdesk: Serving 40,000 users with ~500,000 annual requests.

Device Logistics: Managing 400,000+ IT assets (laptops, screens, mobiles, etc.).

Staff Onboarding: IT setup for new employees.

Roll-out Support: Assisting with deployment and change management of DWP solutions (developed by DIGIT.C.2).

The unit operates through five sectors:

- Front Office: First-level user support, including VVIP assistance.
- Logistics & Inventory: Full lifecycle management of IT equipment.
- Quality & Processes: Ensuring service quality, process oversight, and helpdesk communications (with DIGIT Communication).
- IT Asset Authority Managing DWP IT budget, handling ad hoc product requests and assuming the role of Central Information Resource Manager for DWP.
- Remote Sites: Supporting Commission Representations and other remote EC sites to ensure a suitable and sustainable unified DWP and Audiovisual environment.

The role aims to ensure the efficient, compliant, and financially sound management of Digital Workplace end-user services under the responsibility of the Unit. It supports service quality and cost transparency through the validation of end-user requests, the implementation of chargeback and cost model activities, and the continuous improvement of related procedures, workflows, and policies, in close cooperation with internal and external stakeholders.



WE PROPOSE

DIGIT is seeking to hire an IT Service Assistant.

The position will consist of providing operational, administrative, and analytical support to the management of Digital Workplace end-user services, combining IT service support, policy implementation, and financial and reporting activities in a complex, multi-stakeholder environment. The jobholder will ensure the accurate reporting of Digital Workplace service consumption and contribute to chargeback and cost model exercises for the services under the responsibility of the Unit. This includes liaising with relevant coordinating services and supporting internal service reviews.

The role also covers the validation and processing of end-user requests for IT equipment and software, the handling of incidents and service requests via ServiceNow, and the drafting of formal, reasoned replies. In parallel, the jobholder will contribute to the maintenance and implementation of the corporate IT equipment allocation policy and to the continuous improvement of related procedures, workflows, and tools, in close cooperation with internal stakeholders and support teams.

WE LOOK FOR

We are looking for an IT Service Assistant able to work in a structured, service-oriented, and regulated environment, combining operational reliability with analytical capacity and sound judgement.

The ideal profile for the job is a candidate with relevant education or equivalent professional experience of at least 5 years in information and communication technologies, and a solid background in IT support and infrastructure. Several years of experience in IT support roles, particularly in complex organisations, is considered an asset, as is exposure to financial, reporting, or cost-monitoring activities related to IT services.

The candidate should have good knowledge of ICT, including awareness of IT security principles, and be comfortable using office automation tools, notably Excel and other MS Office applications. Familiarity with IT tools supporting financial or asset management processes, such as SNOW HAM, ABAC, is an advantage.

Strong communication and drafting skills are required, together with a client-oriented mindset, attention to detail, and the ability to work autonomously while managing priorities and deadlines. The candidate should be able to cooperate effectively with others, contribute to a team environment, and support coordination and organisation of work when needed.

Very good knowledge of English and good knowledge of French is required.



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and French.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the Conditions of Employment of Other Servants**, in **function group FG III**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 3 years**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
