STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Employment, Social Affairs and Inclusion DG pursues policy, legislative and financial initiatives to build a competitive social market economy in the EU by shaping and promoting a modern European social model. Through the implementation of the European Pillar of Social Rights and with the help of EU funds, it aims to create more and better jobs, promote skills, improve the functioning of the labour markets and fight poverty and social exclusion.

The objective of Unit D.4 is to contribute to the goals of the European Pillar of Social Rights, support a fair recovery, facilitate the green and digital transitions, and enhance economic and social resilience in France, the Netherlands, Belgium, and Luxembourg.

To achieve this, Unit D.4 leverages its role in the European Semester. It monitors and assesses policy developments in the areas of employment, social affairs, and skills, with the aim of strengthening the evidence base for the development and implementation of EU legislation and policy recommendations across the four countries it oversees.

WE PROPOSE

We offer a challenging position for a highly motivated candidate. The successful candidate will be responsible for the following two main fields:

1. The Implementation and monitoring of specific European Social Fund Plus programmes. Main tasks include monitoring the implementation of selected interventions supported by the ESF (+) and the JTF, representing the Commission in Monitoring Committees and participating in the annual review meetings with the managing authorities, analysing annual implementation reports, drawing conclusions and preparing the positions of the Commission.



2. The monitoring and analysis of employment, skills and social inclusion policies, and development of relevant recommendation proposals. Main tasks include gathering information on changes in the national socio-economic situation and analysis of policy developments, as well as drafting and contributing to the various Commission documents and reports linked to the European Semester and related initiatives.

The jobholder will maintain regular contact with other Commission services, national and regional authorities, as well as relevant stakeholders. The primary focus of these responsibilities will be on France, Belgium and the Netherlands. However, the selected candidate may also be asked to assist with work related to Luxembourg, depending on the unit's needs.

WE LOOK FOR

We are looking for a policy officer with a passion for Social Europe, creative thinking, and a proactive drive. The ideal candidate will have proven experience in social, employment, or economic policies. A strong technical and analytical background is essential, along with the ability to work effectively with statistical data and reports. The successful candidate will be selected based, in part, on their ability to present complex and specialized information in a clear and accessible manner.

Experience working with a variety of stakeholders—including national or EU authorities, international organizations, civil society organizations, and think tanks—is also important. A strong command of English and French, both oral and written, is a big advantage. Knowledge of Dutch is an asset. Previous experience within the European Institutions in the fields of this vacancy is also an asset.

Candidates should possess strong organizational, delivery, and communication skills, as well as a proactive, service-oriented attitude. Sound policy judgment and intellectual curiosity are also essential qualities.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.



The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
