## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [\*\*temporary agents\*\*](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [\*\*contract agents\*\*](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

We are the Budgetary and Financial Management Unit of DG REGIO. Our primary mission is the transparent management of the budget at the disposal of the Directorate-General (DG).

Our unit is organised in five sectors, in charge of the (1) budget, (2) shared management programmes, (3) technical assistance – legal and financial procedures, (4) technical assistance – strategy and (5) financial and contractual management of the Cyprus settlement and financial instruments.

This vacancy is in the financial management part within a small team of administrative agents, whose main responsibilities include:

- Provide information to the staff and management on the unit's operations, results, and issues
- Contribute to improving internal communication and the sharing of knowledge and information within the unit, the Directorate, the Directorate-General, and with other Commission departments
- “Greffé financier” “Budgetary and financial management”, consisting in checking and encoding invoices

### WE PROPOSE

---

Unit A3 of DG REGIO is seeking to hire one administrative support agent.

The position will consist of being the contact point of a Unit composed of 50 people divided in 5 sectors.

Being part of the financial and budget management team, your responsibilities will include:

- Administrative support to the Head of Unit and members of each team, including:
  - Support in management of absences,
  - Assignment of tasks, via Functional Mailboxes, etc.
  - Logistical support in organisation of meetings



- Be the contact point and share information within the Unit
- Perform the first steps of financial operations, support in checks and encoding as Data Entry Agent in SUMMA

## **WE LOOK FOR**

We are looking for a dynamic and motivated colleague who can effectively provide administrative and logistical support to the Head of Unit and member of each team.

The ideal candidate would contribute to and help maintain a positive and collaborative working environment that ensures timely and high-quality deliverables. He/she should be able to work autonomously and in a small team. In executing the administrative support tasks, he/she will have to use various IT tools, as SYSPER, ARES, DECIDE, WEBDOR, VPASS, knowledge of which would be an advantage. The candidate should have good knowledge of English and French.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

Successful completion of compulsory education

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG I**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. The contract may be renewed in the interest of the service for a fixed period up to three times. Any further renewal will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group I must successfully complete a 6-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
