STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [**temporary agents**](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [**contract agents**](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Unit G.4 is one of four units in Eurostat's Directorate for Business and Trade Statistics, and we are in charge of annual statistics in the areas of International Trade in Services statistics (ITSS), Foreign Affiliates Statistics (FATS) and Foreign Direct Investment (FDI) statistics. Further, we publish and develop statistics on Global Value Chains. We aim to consistently provide the Commission with high quality statistics and analyses to support EU policies on competitiveness, productivity, globalisation, innovation and entrepreneurship. Our unit cooperates closely with other Commission services such as DG TRADE, DG GROW and DG FISMA as well as with other external partners, the ECB, WTO, OECD, UNSD and the IMF. There are also regular and close contacts with many other Eurostat units in cross-cutting themes such as European businesses, business registers, balance of payments, and globalisation. At present, unit G4 comprises 19 persons.

WE PROPOSE

We propose a post for an AST to work in the area of globalisation, more specifically on the annual data collections of the international trade in services statistics.

International trade in services statistics encompass the following datasets:

- annual ITSS data, providing information on the value of exports/imports of services traded internationally,



- annual Services trade by enterprise characteristics (STEC) which links the ITSS data to business characteristics of the trading enterprise, and
- annual data on services trade by Modes of Supply (MoS), which provides the value of services supplied by all four modes of supply as defined in the WTO's general agreement in trade in services (GATS).

Work is performed under the supervision of the team leader and in cooperation with other members of the team. The main tasks include:

- Annual data validation: validate and prepare for publication the data of EU Member States, EFTA and candidate countries;
- monitor the quality of the data provided according to agreed standards;
- contribute to the ITSS quality reports, update the online statistical articles on ITSS, contribute to other reports relevant to ITSS;
- contribute to the provision of replies to user requests and
- contribute to the ITSS working group meeting with the member states.

Depending on the successful candidate's interests the candidate may also contribute to other projects in the team, such as the ITSS Asymmetry Resolution Mechanism, methodological developments or process improvements.

The selected candidate will be able to work fairly independently in the team.

WE LOOK FOR

We are looking for a motivated and service-oriented colleague with a strong sense of responsibility and very good organisational skills. The ability to work autonomously and as part of a team, as well as good communication skills and ability to perform under time constraints are of utmost importance. The successful candidate should be knowledgeable in the field of statistics/economics - especially business statistics and data analysis would be an asset. Further, knowledge about databases or programming (e.g. MDT, SQL, SAS, R, Python or similar) and general experience in IT would be an advantage.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
