STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The COMM A1 Social media and visual communication unit, at the heart of the Commission's political communication operations. The unit is in charge of political communication strategy and editorial planning, social media and graphic design. It is made up of almost 50 professionals (including intramuros and extramuros consultants), working in a highly political context. We work with strict deadlines, while remaining adaptable and flexible enough to handle external unforeseen events. We take pride in our efficient co-operation, team spirit and good communication skills, which are essential for our daily work. We offer a good working atmosphere and space for initiatives.

The team in charge of relations with multipliers manages the content creators relationship programme of DG COMM, supports and advises the members of the social media network and Representations about their programmes and the best way forward in working with online content creators.

WE PROPOSE

We are looking for a highly motivated and experienced professional to join our team as an Information and Communication Officer for outreach and relations with multipliers, focusing on relations with online content creators. As a key member of our team, you will play a crucial role in further developing and implementing the DG COMM programme for outreach to and relations with multipliers, serving as an adviser and a host to all activations with content creators. You will take care of a variety of projects, notably regular study visits, bilateral outreach and relationships building. The successful candidate will also provide advice to the wider community of



communication professionals within the Commission working on relations with content creators, by steering study visits and advising on campaigns.

Key responsibilities:

- Contribute to the development of the programme for outreach and relations with content creators.
- Develop and maintain relationships with social media influencers, thought leaders, and content creators to promote EU policies, initiatives, and values.
- Collaborate with colleagues to plan and execute social media campaigns with the participation of content creators, promoting EU initiatives, policies, and events to a wider audience.
- Establish and maintain regular contacts with the influencer management teams of other institutions, ensuring synergies and greater added value
- Monitor social media activity of content creators and propose opportunities for direct engagement.
- Provide advice to the internal team and to the teams inside the social media network on relations with content creators, in view of the successful implementation of influencer relations projects inside the Commission.
- Contribute to the annual budget planning for the content creators outreach programme of DG Communication.
- Manage relations with contractors and monitor the execution and budget implementation of contracts, under the direct supervision of the Deputy Head of Unit.

WE LOOK FOR

Unit COMM A1 Social media and visual communication is looking to hire an INFORMATION AND COMMUNICATION OFFICER - Outreach and Relations with Multipliers.

The ideal candidate should have :

- Proven experience in outreach and relations with third parties, in the EU context.
- Strong knowledge of online content creation, social media, and influencer marketing.
- Excellent project management and implementation skills, with the ability to work independently and as part of a team.
- Strong experience in organising and hosting visits of third parties.
- Strong advisory and communication skills, with the ability to provide expert advice and guidance to internal stakeholders.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AD jobs: In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another EU language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
