## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

The mission of Eurostat's unit ESTAT.C.4 'Price statistics; Purchasing power parities; Housing statistics' is to provide the European Union with high quality consumer price indices, purchasing power parities and real estate price statistics. The unit aims at publishing comparable, reliable and timely statistics in the three domains and further developing statistical standards, methodology and production processes in collaboration with Member States, other partner countries and international organisations. The unit has 22 staff members.

In the domain of consumer price indices where the vacancy is, the unit produces the harmonised index of consumer prices (HICP), which is a comparable measure of inflation across EU Member States. Data are transmitted by Member States to Eurostat on a monthly and annual basis and are broken down by detailed categories of household consumption. The HICP is a very important and visible indicator because it is a Principle European Economic Indicator and is used by the European Central Bank (ECB) to monitor the price stability in the euro area.



## **WE PROPOSE**

---

Unit ESTAT.C.4 is seeking to hire a Statistical Assistant – HICP. Our future colleague will be a member of the team responsible for the HICP. The team consists of 9 persons who focus on methodology and production of HICP.

The tasks include in particular:

- participation in the monthly and annual production process;
- data processing and validation;
- database management;
- drafting statistical publications (news releases, articles, etc.) and process/project documentation;
- quality assessment of data transmitted by EU Member States and other countries;
- contribution to the development of data compilation methodology and testing new indicators;
- support to the further development of the HICP production environment;
- participation in Price Statistics Working Group, task forces and other meetings on the HICP.

This post offers an opportunity to work closely with colleagues in the national statistical institutes of the Member States, EFTA countries and enlargement countries, Commission services and the ECB.

## **WE LOOK FOR**

---

We are looking for a motivated person with a background in statistics or economics or a related field, and with good numerical and analytical skills, capable of working autonomously and resiliently.

Interest in the production of HICP data and the inter-linkages of methodological and production-related issues would be welcome. Knowledge of and experience in price statistics would be an asset.

The candidate should be able to demonstrate prior experience in processing, treating and/or analysing statistical data and some knowledge of statistical databases and software. Knowledge of and experience in price statistics, household budget survey, national accounts and/or other economic statistics would be an asset.

He/she should have appropriate personal skills such as good technical judgement, service-mindedness, sense of initiative, problem-solving attitude, communication, and strong team spirit. Good oral and written communication skills in English are important.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
