STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit AGRI.A.1 is a team of 15 highly motivated colleagues that contributes to the evolution of the Common Agricultural Policy (CAP) and other relevant initiatives by analysing its policy efficiency and defining a long-term strategy for the development of the agri-food sector. Unit A1 monitors developments with an impact on agriculture, food and rural areas in the EU. The Unit works on the preparation of the new CAP for the period 2028-2024 in the context of the new MFF. It also coordinates and monitors the implementation of the Vision on Agriculture and Food as well as the implementation of the simplification agenda on the domain of the agricultural policy.

The members of the team work in close cooperation with other units in DG AGRI, as well as with colleagues in other Directorates-General, and maintain good working relationships with stakeholders, researchers, think tanks as well as national and regional authorities. The Unit manages different platforms of dialogue with the stakeholders across the agri-food chain and monitors the positions of member states and other EU institutions in relation to the future of agriculture and food. It also develops policy narratives and coordinates the preparation of briefings, speeches and relevant policy documents for internal and external use.

WE PROPOSE

The work of the secretary/administrative agent entails assistance and secretarial tasks, organizational and general administrative support to the Head of Unit and the other members of the team. S/he will be responsible for the assignment of tasks and their follow-up within the unit, the follow-up of mails, letters, requests, etc. S/he will be involved in the procedural steps, organisation of internal and external meetings, correspondence management, preparation of travel arrangements (including preparation of mission orders and expense claims), support related to human resource management aspects (SYSPER2), ordering catering and office supplies, as well as other general administrative and logistic support as need arises. This work allows for a wide range of tasks and encourages many contacts with the other units of the DG but also outside the DG. Close collaboration and interaction with the Head of Unit and the whole team are essential.



WE LOOK FOR

We are looking for a dynamic and motivated secretary/administrative agent, who is a team player but at the same time is able to work independently, in order to provide secretarial and administrative support. The ideal candidate should have excellent coordination and organization skills, precision to ensure strict follow-up of deadlines, the ability to manage several tasks at the same time and a good sense of initiative. Adequate IT skills, hands-on experience with various Commission IT tools are required. The candidate should be fully proficient in English. Good knowledge of French would be a strong asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
