STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit AGRI.B.2 is responsible for the environmental and climatic sustainability aspects of agriculture. The Unit is also responsible for forestry.

In particular, our Unit promotes the integration of climate change and environmental objectives into the Common Agricultural Policy (CAP) by supporting the design, development and implementation of targeted CAP measures, and helping ensure their consistency within the so-called “green architecture” of the CAP, in close relation with the relevant climate and environmental legislation and objectives at EU and international level, including the EU Green Deal.

Unit AGRI.B.2 is also coordinating DG AGRI contributions to environmental and climate related policy initiatives and legislative proposals relevant for the agricultural and forestry sectors, collaborating closely with DG Environment and DG Climate services.

We are also co-responsible for the implementation of the EU Forest Strategy and we follow up and contribute to the development of the various aspects of the renewable energy, bio-economy, circular economy policies.

The team is composed of 33 colleagues and enjoys a very pleasant working atmosphere while responding to high expectations on all these very important files.

WE PROPOSE

A position as administrative assistant (SC) to the Unit, to take care of several essential secretariat tasks, such as attribution of tasks in Ares and filing, attribution of Interservice consultations and uploading responses in DECIDE, preparing e-signataires for the Head of Unit or other members of the team, supporting colleagues in the preparation of missions, supporting the head of Unit in managing Sysper, as well as managing the functional mailbox of the Unit. These tasks should be dealt with in a way to help everyone meet deadlines, including by putting in place systems of alerts



and reminders. Together with the two other members of the secretariat, the person will also deal with several horizontal tasks to bring administrative assistance to the team on a more ad hoc basis: update of organigramme on the Intranet, administrative support to newcomers, administrative support for the preparation of team events, booking of meeting rooms and welcoming external visitors, etc. Finally, the person should also be able to support policy officers when needed to manage files in RDIS and Compass Corporate.

WE LOOK FOR

A team player colleague eager to bring administrative support to a busy policy Unit. Ability of communicate orally and in writing to various types of interlocutors (inside and outside the Unit), autonomy, organisational skills, care for deadlines and sense of service are among the qualities which would be highly praised. Experience in managing secretariat tasks in busy policy units would be an advantage. Interest in the Common Agricultural Policy, environmental and climate concerns is also positive.

Recent experience in following systems is required: ARES, DECIDE, MIPS, SYSPER, ATMOS, BASIS. Knowledge of Compass Corporate and RDIS would be a strong advantage. The person should also be fully comfortable to work with TEAMS, Word, Excel and PPT.

A good command of English is required.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
