STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit SG.A.5 is the unit at the Secretariat-General of the European Commission in charge of President’s correspondence and document management for the Secretary-General. We work closely with all cabinets and Directorates- General, ensuring a coordination role and providing a direct support for the President’s cabinet.

Our unit provides a global view of the work of the Commission at high level and gives a daily insight into the main political topics and concerns of citizens. The tasks of the unit allow for a unique overview on the various Cabinets and services’ work.

WE PROPOSE

Unit A.5 of the Secretariat-General is seeking to hire an administrative assistant.

The position will imply to participate mainly (but not only) in the handling of President’s or Secretary-General’s correspondence. Together with other colleagues, you will contribute to the management of correspondence addressed by a broad range of interlocutors (citizens, organisations, MEPs or politicians). Tasks could include e.g. registration and assignment of correspondence, management of draft replies, including the follow-up of deadlines, management of files in functional mailboxes, or the launching of validation workflows, and dispatch of replies. On basis of your linguistic skills, you will be invited to take part in the drafting of simple replies (or in performing a linguistic check and finalization of drafts prepared by services).

To be able to ensure business continuity all year long, each member of the unit has a back-up for replacing her/him during absences and contribute also to backing-up other colleagues when needed.

You would also be called to lend your support to the Head of Unit for few tasks like organisation of unit meetings or cabinets & services correspondents’ networks’ meetings.



WE LOOK FOR

We are looking for an administrative assistant profile.

The ideal profile for the position is a candidate with good knowledge of the functioning of the Commission; very good organisational skills, a sharp eye for detail, and be at ease in working with various interlocutors (cabinets, services). Good communication and networking skills, and a good ability to ensure effective coordination are essential.

Proficiency level (“native”) in written English, and/or strong command of French/German (preferably native). Any other European official language is an asset.

The successful candidate will work daily with the standard Commission IT tools, e.g. Ares, Word, Excel, for which a very good knowledge is required. Experience with the Commission’s work and procedures would be helpful for a quick understanding of the job and integration in the team.

Strong team spirit, client service orientation, and personal engagement are key factors as well as an aptitude for diversified tasks and flexibility. You should be a very good team player but also capable of working autonomously and be resilient to pressure.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- Have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
