STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Paymaster Office (**PMO**) or Office for the Administration & Payment of Individual Entitlements is responsible for providing high-quality and user-friendly service to current and former staff of the Commission and most other EU institutions, bodies and agencies. It does so by promptly and accurately establishing and paying entitlements and claims, providing clear and relevant information, and ensuring an efficient and effective system of management and control.

Unit PMO.5 is mainly located in Luxembourg and manages:

- the Joint Sickness Insurance Scheme ("JSIS")
- all travel management for the Commission and most other EU institutions, bodies, and agencies ("EUIBA")

It also includes one horizontal team – Contracts and financial management, in charge of managing interinstitutional contracts in the domains of corporate credit cards and work-related travel insurance and events. The vacant post is to be filled in this team.

WE PROPOSE

An interesting position as an Administrative Agent – Interinstitutional contracts in PMO.5 – Contracts and Financial management team, dealing with external service contractors, and particularly the insurance coverage during work-related mission/authorised travels.

Under the supervision of the team leader, the successful candidate will:

- provide oral and/or written response to mission managers (from PMO.5, the Commission and other EU Agencies and Bodies) on questions relating to corporate insurance coverage (i.e. type of coverage, missions to countries at risk, claim forms).
- if needed, support the financial team with the invoicing cycle with different service providers as approved by the Commission.
- if needed, provide support to colleagues in the team in operational and/or financial



management of other interinstitutional contracts: travel agency, corporate credit cards and chartered flights.

WE LOOK FOR

We are looking for:

- A dynamic, well-organised and motivated colleague with a strong sense of service and attention to detail.
- The ideal candidate has at least 2 years' experience related to insurance coverage, in particular in the context of work-related missions or authorised travel, and is comfortable providing clear guidance to colleagues on related procedures.
- The candidate should be able to organise their work in a structured way, show initiative and pragmatism, and communicate clearly both orally and in writing.
- The position requires the ability to work effectively within a small team as well as independently, while handling several requests simultaneously, maintaining a high level of accuracy, and adapting to evolving operational needs.
- Knowledge or relevant experience in the field of finance/insurance would be considered an asset.

Operational knowledge of French or English is essential, and good knowledge of the other language is a strong advantage. Knowledge of any other EU language is an asset.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in a single pdf in the following order:
 1. your CV

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this [link](#).

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. The contract may be renewed in the interest of the service for a definite duration. If a second renewal of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
