STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Digital Services enables, drives and supervises the Commission's digital transformation and the transformation of its IT delivery model. It ensures that the digital landscape in which we operate is robust, resilient and secure, supports digital-ready policy making across the Commission and facilitates stronger collaboration between European public administrations.

DIGIT Unit R.2 Budget and Finance is a large and friendly unit of 35 colleagues. The work is interesting and varied as our three sectors are managing projects at Unit, DG and corporate level. We are responsible in DIGIT for budgeting (draft budget, programming and monitoring of execution), accounting (establishment of the financial accounts of the DG and performing the annual accounting quality program), financial transactions (financial initiation and verification of commitments, payments, recovery orders for chargeback of services, and the authorization of payments and recoveries for chargeback) and managing agreements with customers for the services DIGIT provides to customers (Memorandum of Understanding/Service Level Agreements). Given Directorate R strategic role in DIGIT, our Unit is also engaged in key cross-unit projects.

WE PROPOSE

We propose a position as Financial Officer in the Revenues and Accounting Sector of the Unit. The position will be key in driving the digital transformation and automation of the revenues (chargeback) and costing processes of DIGIT. This includes data management, data modelling and data governance together with local system owner responsibilities. Setting up business requirements and processes and the representation of the Unit/Sector in various stakeholders meetings on the subject are an important aspect of the job.

The coordination and close collaboration with relevant Units of DIGIT and other DG stakeholders and customers on initiatives related to the modernization of the IT landscape in the budget and financial domains is a key task. The jobholder can also be part of any interdisciplinary group in



charge of defining DIGIT's future IT landscape, identifying and shaping crosscutting areas. Change management and transition management are essential and challenging elements of the job.

WE LOOK FOR

We are looking for a dedicated and dynamic personality who has at least 3 years of proven experience in financial data management in the area of ITC, including implementation of budgetary or financial processes. The ability to identify and translate business needs and requirements into technical capabilities is key.

The candidate will also have an excellent knowledge of IT budget and finance tooling, ideally within the European Commission corporate landscape. Knowledge of software development, lifecycle/methodologies and costing models is an absolute must. Practical experience with the Service Now platform is an advantage.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of English
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 3 years**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
