STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [**temporary agents**](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [**contract agents**](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG Trade and Economic Security is in charge of leading the EU's common commercial policy, one of the exclusive competences of the EU. Trade policy plays a critical role in enhancing the EU's economic competitiveness, shaping globalisation, and defending the EU from unfair trade practices and threats to its economic security.

As an important part of its trade policy, the EU makes use of available autonomous tools such as the EU Trade Defence Instruments (TDIs) - (anti-dumping, anti-subsidy and safeguards). These tools protect our citizens and industries against unfair trade practices at international level – their increased use in recent years, in a changing global context, is a testimony of a more assertive European Union, necessary to put globalisation to good account and to ensure a level playing field in international trade.

The EU policy of TDIs and their implementation and execution are centralized in Directorate G of DG Trade and Economic Security, under the supervision of the Chief Trade Enforcement Officer.

The mission of the Unit TRADE.G.4 is to carry out trade defence investigations in accordance with the legal requirements, deadlines, standards and practice of the Directorate G.

The Unit is also responsible for monitoring and enforcement of price undertakings and measures in force as well as for admissibility of refunds and management of the bicycle parts exemption scheme.

WE PROPOSE

We propose an interesting position as an assistant case-handler to join a dynamic and enthusiastic section of 12 colleagues.

The selected candidate will be responsible for the admissibility of refund applications for paid anti-dumping and countervailing duties and for investigating companies' requests for exemption from anti-dumping duties under the bicycle parts exemption scheme, which requires on-site visits within



the EU to investigate if companies are complying with the rules of the bicycle parts exemption scheme. The position requires extensive contacts with the importers/exporters, their legal representatives and various Union producers.

We offer a rewarding assistant case handler post working on cases with very tangible results on the ground, ensuring fair competition and a level playing field for EU companies.

In view of the specific requirements needed for the job, DG Trade and Economic Security provides intensive training on Trade Defence Instruments for new colleagues in Directorate G, as well as structured coaching by experienced case handlers.

WE LOOK FOR

We are looking for a colleague with a curious and inquisitive mind, a background in accounting, customs, auditing, economics or law, and strong IT skills - a combination that will enable him/her to analyse in detail the refund applications and the exemption requests.

The candidate should have very good drafting skills, mainly in English. Experience with customs issues, especially in tariff classification, customs nomenclature, origin and special procedures is considered an asset.

Other essential requirements include a sense of initiative, the ability to work under pressure, an eye for detail, and availability to travel on missions within the EU. Respect for deadlines and confidentiality is crucial.

Very good knowledge of English is essential, while knowledge of other EU languages and/or previous experience in the field of trade defence would be an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
