STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Chief Technology Officer advise the Commissioner responsible for Competition and the Director-General of DG COMP on technology matters, guides and oversees data-related and digital initiatives and work streams for DG COMP. He oversees the activities of Unit CTO.1 which uses the latest technologies to deliver solutions meeting the enforcement needs of operational units across all competition instruments (cartels, antitrust, mergers, DMA, FSR). More specifically, he oversees the work of Unit CTO.1 for forensic support for inspections, intelligence to prepare inspections or as required by competition investigations, eDiscovery support to review large submissions as well as technology advice as needed in competition investigations.

WE PROPOSE

We offer an interesting and challenging position as Secretary to assist the Chief Technology Officer and the Unit CTO.1 in a friendly and motivating working environment and with a large degree of autonomy in organising your work.

The Secretary responsibilities include:

- Efficiently manage the Director’s diary and schedule, ensuring optimal time allocation.
- Screen and prioritize incoming telephone calls and correspondence.
- Liaise with internal and external stakeholders to arrange meetings and prepare relevant - documentation.
- Manage office supplies and make travel arrangements as required.
- Assist with HR recruitment processes and personnel administration for the unit.
- Ensure follow-ups to keep up deadlines for any briefing or other submissions by the unit.
- Support the logistical arrangements for European Competition Network working groups, training sessions or other meetings organised by the Unit.
- Act as a back-up to the other administrative personnel in budgetary and financial matters.



The unit has a secretary to the head of unit and a financial assistant, forming the administrative team of the unit, with which the secretary to the Director will closely work.

WE LOOK FOR

We are looking for a dynamic, proactive and detail-oriented Secretary to support the Director (Chief Technology Officer) to ensure smooth administrative operations and communication within the team, supporting the Director in various organizational tasks.

The internal working language of the CTO is English, but knowledge of French could be an advantage.

The ideal candidate will be highly responsible, reliable, and motivated, with excellent organisational and multitasking skills.

Proficiency in MS Office, including Word, PowerPoint, Outlook, and Excel, is required.

Candidates should have prior experience in administrative roles, showcasing the ability to communicate effectively and professionally. Experience assisting in a high-level management setting would be a plus.

The successful applicant will demonstrate the ability to work collaboratively as part of a team in a fast-paced environment, exhibiting strong problem-solving skills and attention to detail.

Familiarity with Commission ICT tools as well as a solid understanding of administrative, financial, and personnel procedures, would be an advantage. Additionally, we seek a candidate who can collaborate across services and coordinate tasks to support colleagues effectively.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
