STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

BUDG C1 is in charge of managing the Commission's treasury, as well as the treasuries of the other entities for which the Accounting Officer of the Commission is responsible, such as the European Development Fund (EDF), the European External Action Service (EEAS), EU Trust Funds and a growing number of agencies to which the Commission provides central treasury services. The Central Treasury is responsible for cash forecasting and maintains direct contact with national central banks, treasuries, and commercial banking partners to ensure the smooth implementation of cash management policies. It executes all the payments for the above-mentioned entities (more than 3 million payments per year) and also actively contributes to the establishment of policy instruments with regard to their funding and cash management structures (e.g. Next Generation EU, Common Provisioning Fund, ULCM etc.).

The treasury of the Commission is also managing the Own Resources accounts (GNI, VAT...), receiving the amounts paid by the Member States to the Budget of the European Union. It replenishes the other institutions' treasury on their request (EEAS, Council, Parliament...) and offers Treasury services for paying and receiving the cash on behalf of external entities.

WE PROPOSE

We are offering an opportunity to join Unit C.1. The successful candidate will provide administrative, organisational and coordination support to the Head of Unit and the Unit as a whole. The selected candidate will contribute to the efficient functioning of the Unit by providing comprehensive administrative assistance and supporting internal workflows.

The post holder will work closely with the Head of Unit and approximately 35 colleagues across the Unit to ensure smooth daily operations, support to management activities and provide coherent follow-up on HR-related administrative processes. This role combines secretarial and organisational support with coordination tasks relating to staff follow-up, planning activities and interaction with horizontal services.

The successful candidate will contribute to the organisation of meetings and missions, support document and information management using corporate tools, and ensure the effective communication and follow-up of administrative procedures in line with Commission rules.



WE LOOK FOR

We are looking for a proactive and well-organised colleague with a strong sense of service and the ability to combine administrative support with coordination responsibilities in a dynamic working environment. The candidate should have experience in administrative support, and the capacity to coordinate HR-related administrative processes and ensure follow-up of actions across the Unit. The job holder should demonstrate organisational and planning skills, the ability to prioritise and meet deadlines, and strong interpersonal and communication skills for interacting with management, colleagues and horizontal services. Discretion and reliability when handling sensitive information are essential. A good command of corporate IT tools (such as ARES, Sysper, MIPS, SharePoint, Teams and Office 365) is required. A very good command of English is required and knowledge of French would be advantageous.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
