## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The Secretariat-General is the main service of the President and it closely coordinates its work with the other presidential services and the central services which, together with the Secretariat-General, ensure the smooth functioning and operation of the institution. Under the authority of the President, it serves the whole College, oversees the implementation of the European Commission's political priorities and ensures the collegiality, the consistency, the efficiency and the regularity of the Commission's action.

The Secretariat-General fosters the Commission's institutional competences, good governance and the development of a service-oriented, modern, transparent and responsible EU administration, which works to highest standards of ethics and integrity.

The office of the Secretary-General of the European Commission is a small and dynamic team assisting and providing support to the Secretary-General and Policy Assistants of the Secretary-General. This office works closely with the office of the Head of Cabinet of the President and the offices of the Deputies Secretary-General.

### WE PROPOSE

---

A motivating and challenging management support post within the Office of the Secretary-General. The selected candidate will provide secretarial and administrative assistance to the Head of Unit and Deputy Head of Unit of the office of the Secretary-General and will support the Secretary-General in a fast-paced working environment.

The daily tasks include, among others:

- organising the work of the team of the Secretary-General and managing the agendas of the Policy Assistants,
- organising and preparing meetings of the Directors-General, Assistants to the Directors-General, of the Senior (and Middle) Management of the Secretariat-General,
- ensuring document and mail management, including attribution and due follow-up of correspondence,



- organising missions,
- performing quality checks and processing notes for the signature of the Secretary-General,
- coordinating the briefing requests for the Secretary-General,
- assist the Head of Unit and the colleagues in the unit with internal communication processes

## **WE LOOK FOR**

We are looking for an experienced colleague who:

- is highly motivated to work in a fast-paced environment and flexible to occasionally manage demanding working hours.
- has a thorough understanding of the Secretariat-General;
- has proven extensive administrative skills (including good knowledge of the Commission's procedures and IT tools. Experience in document management is considered an asset
- has high sense of initiative and responsibility and is capable of working efficiently both independently and as part of a team
- is working with discretion, deals courteously with people and manages confidential matters in a professional manner

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### Qualifications:

FOR AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
